Introduction

The 2015 Parks and Recreation Master Plan addressed the Parks and Recreation and Open Space Element in six sections: (1) an overview of existing conditions, (2) the existing parks and recreation system, (3) a needs and priorities assessment, (4) the long-range Parks and Recreation vision, (5) implementation of the plan, (6) and the Comprehensive Plan goals, objectives and policies as they relate to the Recreation and Open Space Element. The following plan attempts to update these elements to further meet the recreation and open space needs of our community.

Executive Summary

Overview of Existing Conditions

Included in the following assessment and plan are more current statements of existing conditions in the City of Fernandina Beach as they relate to recreation and open space. Historical information in the 2015 Master Plan has been updated to include how the city's parkland was historically created and how its historic platting continues to impact the city's ability or inability to provide parkland for recreation in the future. Major industries were also updated to reflect current conditions, and how tourism and the growth



of Nassau County has affected the usage of recreational offerings within the community over the last five years. Population growth estimates changed, visitor and non-city populations impacting Parks and Recreation offerings were identified, the seasonal population was included as required by state statute. Surprising demographic, economic, and age profiles for Fernandina Beach from the recent 2020 U.S. Census have been included. All of these

elements will likely heavily impact the future services and offerings of the Parks and Recreation department in the next five to ten years.

The Existing Parks and Recreation System

An assessment of the city's parks and facilities was conducted by members of the Parks and Recreation Advisory Committee utilizing online forms which assessed parks and recreation facilities for the key elements of access, comfort, and ADA compliance, as suggested by the National Recreation and Parks Association. The assessment form also included questions concerning maintenance and safety. A photo inventory of park amenities and facilities was also created to document future changes in the city's parks and recreation system and provide documentation for insurance purposes. A current listing of the programs of the Parks and Recreation department has also been provided.

Existing Park Amenities Assessment

The following assessment is dedicated to the documentation of existing conditions of park amenities within the city limits of Fernandina Beach. It has been compiled utilizing recommendations from the National Recreation and Parks Association, the American Disabilities Act, and Florida statutes.

Needs and Priorities Assessment

Utilizing the citizen survey questions of the 2015 Parks and Recreation Master Plan, and its additional focus questions, an updated online survey was conducted to encourage the community to participate in a needs and priority assessment. The committee received responses from 1,200 respondents in the community. 935 were verified to be city residents, 243 were non-resident respondents, and 22 had no

address for residency verification. Outreach included the use of websites, social media, video, business cards, utility bill inserts, signage, and readily available paper surveys.

Survey Summary of Responses

Of all of the city's parks, open spaces, and facilities residents visited the most, *in order of importance*, survey respondents relayed that they utilized the beaches (821), Egan's Creek Greenway (643), and the waterfront (610) the most for their recreation. When asked what they liked about their parks, *in order of importance*, they enjoyed their easy access to the city's parks and facilities with convenient, nearby locations (227). Almost as important to them was their ability to enjoy nature and enjoy the natural state of their parks (221). To a lesser extent, they enjoyed their parks' cleanliness, but thought they were well-maintained, and enjoyed the open space that allowed for walking or hiking. However, they emphatically disliked the trash and litter left behind by others (99), and some residents expressed a concern that it was becoming increasingly more difficult to park (60) at their chosen location of recreation. To some, restrooms that were in need of updating, closed, or were not clean were of concern (48). Some city pickleball players requested more prime court time (22), and some found that their access to pool facilities was limited by work schedules or competing aquatic classes. In general, residents seemed to be split on whether they would support additional taxes, fees, or a bond to fund future recreational improvements (yes:464), (no:405). 106 wanted no additional money spent and 35 wanted better money management. The largest capital improvement request was for safe bike and walking trails (45).



The Long-Range Parks and Recreation Vision

From the citizen survey, the city's 2020 U.S. Census demographic profile, a duplication of services assessment, and the need for the department to develop new revenue streams, certain themes emerged. (1) Citizens enjoyed easy access to the natural environment of the park system, the beaches, trails and nature, and waterfront. (2) The purchase of additional equipment, new buildings or facilities requires large amounts of capital investment with continued maintenance costs. (3) The structural facilities often compete with private entities offering the same recreation services.

To satisfy the expressed needs of the community, the department should be encouraged to pursue programs that further promote the enjoyment of nature and the outdoors (which are also less costly to construct and maintain). Further promotion of more outdoor sports and games by age demographic (adult and 65+) such as chess, checkers, and backgammon would encourage more social cohesion in a transient population. The provision of more aquatic and court space, solely for city residents, may be warranted if usage numbers reflect a need. In utilizing the city's newly acquired conservation lands, new opportunities for low cost, passive recreation may meet city residents continued demands for more trails and views of nature.

To fund future improvements, the public's desire for additional fees may be utilized along with moving toward a for-profit, digital, educational, historical or nature-based tour system of the city's parklands which targets the tourist population. Other for-profit streams of revenue could also substantially assist with budgetary shortfalls to maintain affordability for residents living at or below the Poverty Level. Offering

partial Impact fee funding to other agencies to construct future shared facilities may be advantageous in leveraging the future declining amount of Impact Fee funds produced from development.

Implementation of the Plan

Many of the strategies recommended in the Action Plan were focused on generating sustainable funding for the existing parks and recreation system and promoting efficiency. Strategies included gaining grant funding through the National Recreation and Parks Association. Strategies for monitoring the usage of visitors and non-resident populations were suggested to provide fee pricing platforms and evidence of need to the Amelia Island Conference Center & Visitors Bureau for future funding. Other topics included building social cohesion, meeting demographic needs, and ways in which the department could continue to support the City's environmental and resiliency efforts. Plan details can be found in Section 5: Implementation Plan.

Section 1: Overview of Existing Conditions

1.01 Updated Historical Changes and Outside Forces

History Affecting Recreation Planning:

The Old Town of Fernandina Beach, a historically significant site, was officially established and platted by the Spanish in 1811. Subsequently occupied and reoccupied by three Old-World European countries, its historical plat remains an integral part of Old Town's planning culture with recreation centered on a historically platted San Carlos Plaza and Bosque Bello Cemetery. In 1857, with the southward expansion of the city necessitated by the construction of a rail line to Cedar Key, the city's bustling waterfront and small residential lot sizes were drawn out by the Florida Railroad with little regard for recreational needs. Historic Fernandina Beach remains largely defined by its historic platting of 1811 and 1857. However, outside of the city's historically platted areas, it has adopted larger lot sizes for housing, included subdivisions, and has set aside areas for commercial and industrial development and recreation. However, with large sections of the city lacking platted recreation land due to historical platting from the 1800's, the city continues to face challenges in the future in meeting an accessibility standard of providing a park within ½ mile of every residence.

Changes in Open Space and Conservation Land:

In an attempt to save environmentally sensitive lands and the need to substantially decrease flood insurance rates, the city has made considerable progress in purchasing land and rezoning residential land to conservation. With almost all of the recreation zoned land in the city dedicated to active use, these lands offer opportunities for passive recreation in the future. Additional open space has also been created to promote resiliency with the enactment of ordinances requiring areas to be set aside for stormwater management. An increased pervious surface requirement for residential and commercial development has also created additional open space through the adoption of recent Land Development Code amendments.

Changes in Economic Development:

The 2015 Master Plan historically attributed the major economic development of the City of Fernandina Beach to the Port of Fernandina. Today, according to the Nassau County Economic Development Board (NCEDB), many industries in the city far surpass the employment numbers of the Port of Fernandina.

According to the Nassau County Economic Development Board, major employers on Amelia Island include WestRock, Rayonier Advanced Materials, Baptist Medical Center, senior living and care centers, the Omni Plantation, the Ritz Carlton, and various local, governmental agencies. The NCEDB is further attempting to diversify the area's economy in the future with higher paying jobs in the technology sector. 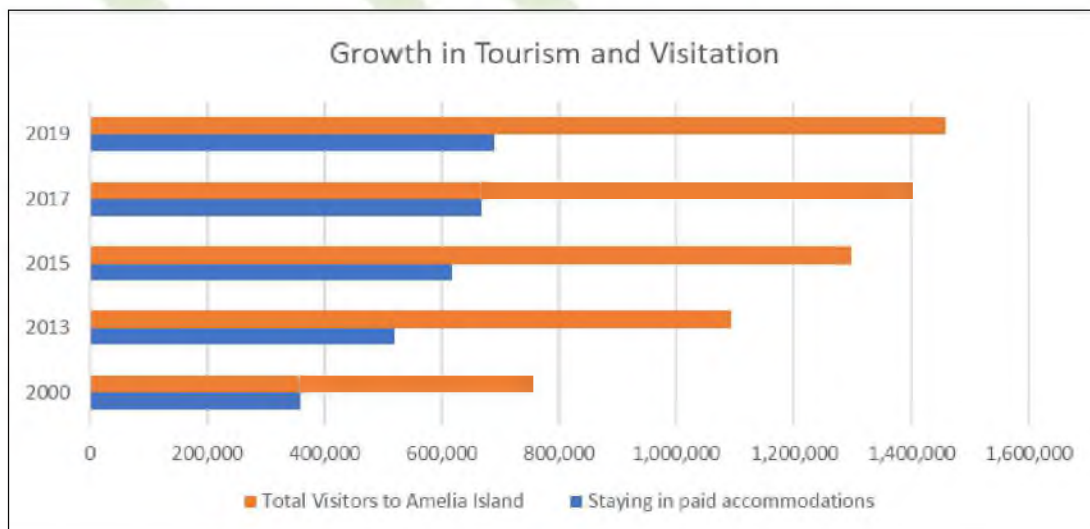

Changes in Tourism and Expendable Income:

Despite all of the city's major economic drivers, tourism and rising household income levels in the city have likely been the most instrumental in changing the nature and number of recreational opportunities privately offered within the City of Fernandina Beach in the past five years. Paddle boarding, fishing charters, kayaking adventures, multiple types of yoga classes, fitness classes, surfing lessons, and tours are among a few of the offerings to have arrived with the rise of tourism and more expendable income (Appendix A).

With the recent construction and expansion of the Nassau Council on Aging on Island Walk Drive, more recreational options have also been given to the city's older, less active population. Nassau County's investment in this facility negated a city need for the construction of a Senior Center as proposed in the 2015 Parks and Recreation Master Plan.

The 2015 plan also advocated greater visitation to Main Beach Park with an Avenue of Flags. This need was met by tourism and expendable income with the addition of a larger hotel and an additional popular eatery. The scarcity of parking at this site provides further evidence of its increased usage and popularity.

Changes in revenue:

Another historic change to note concerning revenue sources dedicated to recreation is the community's desire to increase funding for Parks and Recreation amenities. The 2015 Parks and Recreation Master Plan recommended an increase in the city's Parks and Recreation Impact Fee. In January of 2019 the City Commission of Fernandina Beach followed the 2015 recommendation. The Commission increased the city Parks and Recreation Impact Fees by 58%, allowing growth to further absorb the cost of new recreational amenities (Appendix B).

Changes in population estimates and growth projections:

In 2015, the Master Plan's residential population projections for Fernandina Beach were obtained from the University of Florida's Bureau of Economic and Business Research (BEBR). The city's anticipated population was estimated to be 13,337 in 2020. The recent April 1, 2020 U. S. Census Bureau reports the population of Fernandina Beach as 13,052, adding 1,565 people to its population since its last census count of 11,487 in 2010. The University of Florida (BEBR) anticipates the city's largest amount of future permanent population growth to occur between 2020 and 2030.

Changes in Seasonal Population Estimates and Projections:***Florida Statute 163.3177 (1) Required and optional elements of comprehensive plan; studies and surveys***

"3. The comprehensive plan shall be based upon permanent and seasonal population estimates and projections, which shall either be those published by the Office of Economic and Demographic Research or generated by the local government based upon a professionally acceptable methodology . . ."

Florida Statute 163.3164 (42) defines the term “seasonal population”. “Seasonal population” means part-time inhabitants who use, or may be expected to use, public facilities or services, but are not residents and **includes tourists, migrant farmworkers, and other short-term and long-term visitors.**

The city’s previous 2015 Parks and Recreation Master Plan’s seasonal population numbers were obtained from a Nassau County Growth Management Department affordable housing study. For the purpose of planning for recreation and open space for seasonal populations, the updated, extensive volume of tourism data collected by the Amelia Island Conference Center and Visitors Bureau (AICCVB) was utilized (Appendix C).

The Amelia Island Conference Center and Visitors Bureau estimates that the seasonal population almost doubles the city’s population, between 8,951 and 10,506 nightly visitors, during the city’s summer season. Estimates of future growth of the industry on Amelia Island and in the City of Fernandina Beach are dependent upon many factors. However, due to the island’s finite land mass, making future predictions of the city’s seasonal lodging population will likely become easier to predict in the near future.

Changes in Park and Facility Usage:

The Amelia Island Conference Center and Visitors Bureau (AICCVB) also identifies population sectors which may tend to utilize parks and recreation facilities beyond hotel visitations. Verified through the services of Research Data Services, **an estimated 1.3 million daytrips to Amelia Island were also recorded over the past 12 months (July 2020 to July 2021).** Of this day-time, non-resident population, one segment frequently utilizes the city’s recreation services. Non-residents from the nearby unincorporated portions of Nassau County who lack recreation services and facilities find city recreation services amenable (historical usage data, Appendix D).

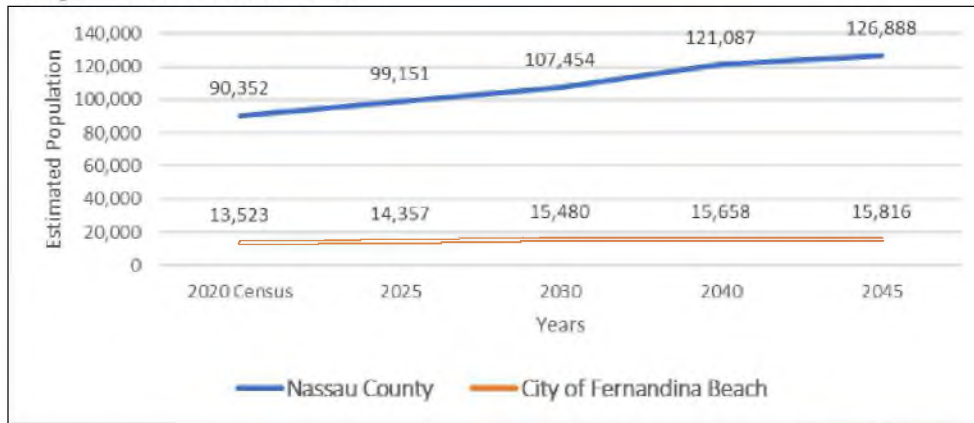
Unless the unincorporated areas of Nassau County construct their own recreation facilities and services, pressure from the unincorporated sections of Nassau County to utilize the city’s recreation lands and services will likely increase as the population of Nassau County continues to grow. *At the projected rapid growth rate of 6,000 to 9,000 residents every 5 years, at a minimum, Nassau County will add a population the size of Fernandina Beach to its population every 10 years.* See the table below.

Comparison of Growth Trends



Though the City of Fernandina Beach maintains free public access to its parklands and maintains minimal fees for facility usage, it is important to note, **in general, the city's nearby, growing population of non-city residents are financially equipped to pay for city and county recreational amenities.** *The 2020 Census data maintains that half of the population of Nassau County has a household income of more than \$69,943 per year with 9% of its population living at the Poverty Level. In contrast, half of the households of Fernandina Beach subsist on less than \$63,942 per year per household with 12.5% living at the Poverty Level.* Despite a larger number of non-city households possessing higher median household incomes, nearby unincorporated Nassau County residents continue to utilize the recreation facilities and services of Fernandina Beach rather than fund their own services.

Changes in the Population Rate of Turnover:

Recent demographic information from the most recent 2020 U. S. Census suggests that the City of Fernandina Beach has experienced a significant turnover in population between 2015 and 2020. Due to the nature of the city's burgeoning, transient, seasonal population, and the recent findings of the growth of a significant population over the age of 65, **community cohesion will likely become more difficult to maintain.** Residential properties will likely continue to turn over due to the age of the population or due to the demand for seasonal use. Over the last four years, a fairly consistent estimated average number of listings and sales has occurred at the rate of 1,049 homes per year (Appendix E). The 2020 U.S. Census counts 5,631 total households in the City of Fernandina Beach.

Parks and Recreation's role in encouraging social cohesion has been assistive in the past, however it will likely become **more critical in the future** if the city is to maintain a core sense of community, or the "small town feel", for which it is noted.

1.02 Demographics

Much has changed in the city's demographic profile since the adoption of the 2015 Parks and Recreation Master Plan. Fernandina's population segments which changed significantly are the age groups of 65 and older and the size of the city's African American population. **From 2010 to 2020, the City's 65+ age group grew 72%.** Over ten years it grew from 20% of the population to 34.4%. (This age group's participation in the 2021 Parks and Recreation Citizen Survey was 40% of the survey's total respondents.) However, over the last ten years a **34% decline has occurred in the city's African American population.** And despite the continued increases in the city's Median Household Income, **12.5% of the City's residents are presently reported as living below the Poverty Level.**

A Dramatic Shift

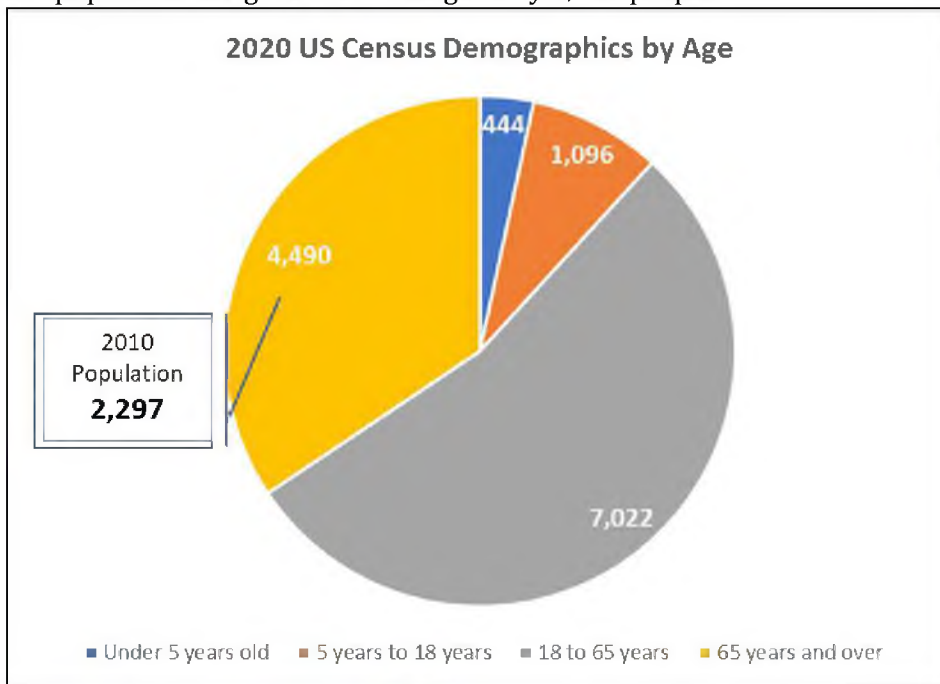
Due to a dramatic shift in the demographic profile of the city's residents toward an older population, **the department will likely need to reevaluate its future recreational services and programming to meet the needs of an aging population.** Finding recreational programming to promote social cohesion within this older community, due to an anticipated regular turnover of housing due to age and seasonal population changes, will likely require more outreach to neighborhoods, community organizations, and church groups.

It is important to note that the total population of Fernandina Beach only grew by 1,156 residents from 2010 to 2020. However, between 2010 and 2020, the population of individuals 65 and older grew disproportionately by 2,193 residents. The population of 65 and older was 2,297 in Year 2020. The 2020 Census now records 4,490 residents age 65 and older residing in the City of Fernandina Beach. More collaboration with the Council on Aging will likely need to occur in offering future services and programs for this newly arrived, growing segment of the city's population.

Another Significant Shift in Demographics

Year 2020 census data confirms a significant loss of the city's African American population. **A 15.9% population in Year 2010 diminished to 10.5% of the city's total population.** With a significant loss within the African American community, an attempt was made to locate data on the age profiles within this community. No data could be reasonably found or compiled on age profiles within the city limits. Without this data, recreational programming to meet **the needs of the community in the future will likely need to include a more systematic, informal outreach on the part of the department to promote inclusion.**

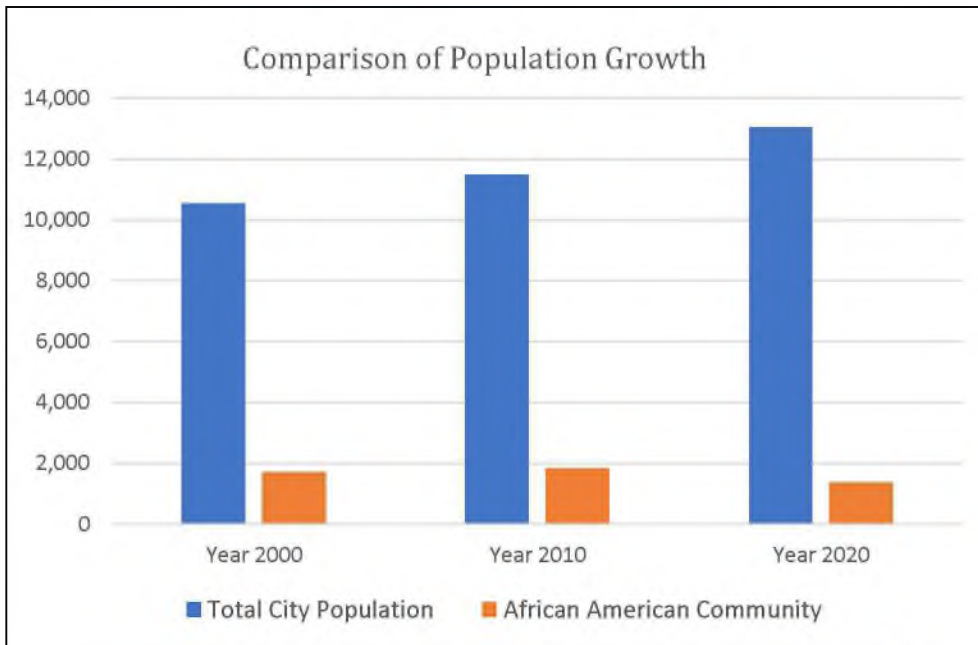

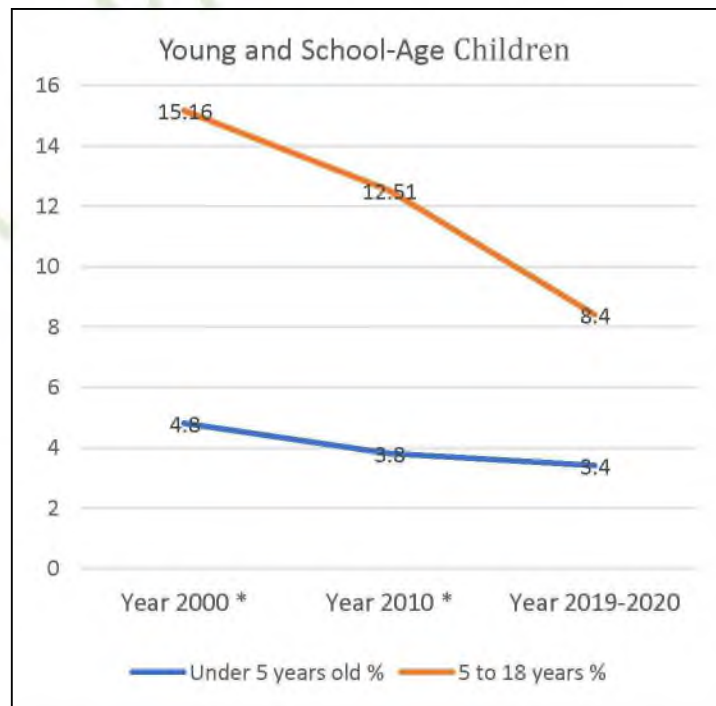
Comparison of Population Segments



The consistent decline in households with young and school-age children should also be noted. Future active recreation resources and programming supplied to residents below the age of 18 may require a more targeted approach to ensure that funding is allocated efficiently to solely meet the needs of a small and declining population of youth.

The City may also find it more cost-effective to further urge Nassau County's Parks and Recreation department to prioritize the needs of this population in the very near future. Tourism may also play a role in continuing to require an investment in the seasonal population of youth.

Section 2: Existing Parks and Recreation System

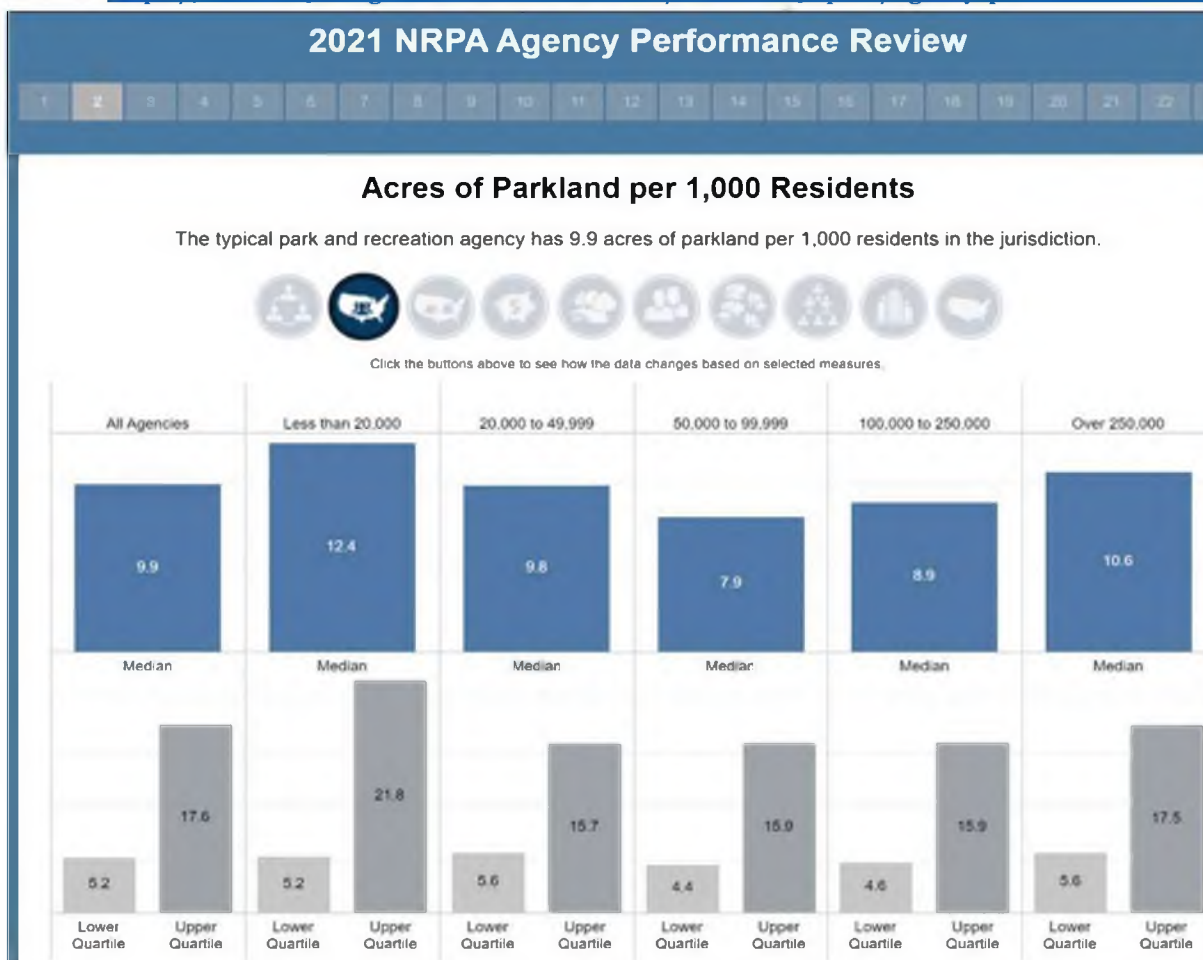
2.01 Existing Parkland: Level of Service

Over the years the amount of parkland allocated to residents of states, counties, and municipalities has traditionally been viewed as a measure of quality of life for its citizens. The higher the number of acres of parkland, the higher the quality of life. Parkland has also become highly valued in municipalities in providing a sanctuary from traffic congestion, asphalt, and concrete. Research has shown that parkland lowers temperature levels which prevent heat islands. Not only do parks provide space for outdoor activity and exercise, they have also been shown to reduce crime and raise property values.

Presently the 2015 Parks and Recreation Master Plan utilizes a minimum standard of 12 acres of parkland per 1,000 residents. No minimum standards have been recommended by the National Recreation and Parks Association (NRPA). The NRPA allows communities to determine their desired quality of life with the amount of parkland they wish to offer their residents. **Utilized as a quality-of-life indicator, Fernandina Beach is well placed with an estimated 26.73 acres per 1,000 residents (seasonal population included) (Appendix F).**

To offer some perspective on the variation between municipalities: New York City offers 2.83 acres per 1,000 residents (2015), Jacksonville, Florida offers 75.3 acres per 1,000 residents (2020), New Orleans offers 71.1 acres per 1,000 residents (2020), Miami Beach requires 4 acres per 1,000 residents (2017 Master Plan).

2.03 Existing Parks and Facilities Assessment

Online Evaluation Form & Photo Inventory

The Parks and Recreation Advisory Committee (PRAC) members evaluated the department's existing parks and facilities utilizing online forms. Since the department lacked a detailed listing, or inventory of each park's amenities, members also collected an online photo inventory to record existing amenities. The inventory was also utilized to create the first two pages of each park's assessment to further educate the public on the extensive offerings of the City's Parks and Recreation system (Appendix G).

Page 1 was created as a “quick snapshot” for users and readers which can be utilized to generate interest in visiting the city's parks and recreation facilities. It contains a photo collage and a quick list of amenities for each park/facility. It also serves as a historical inventory of the park's features. Photos not placed in the collage were archived for future reference in a pictorial inventory of the park facility.



Page 3 of each park's assessment was designed to assist staff and the committee members with the task of assessing the level of comfort, access, and ADA compliance as recommended by the National Recreation and Parks Association. Assessment questions also verified the existence of amenities, maintenance assessments of specific park elements, and assessed possible safety issues. The online comment space offered members an opportunity to identify specific items of concern or possibilities for future uses (Appendix G).

Page 2 gives a more detailed summary of each park that describes its present uses, what a visitor may anticipate when visiting, or the availability of the services offered at the park or facility. A map location was also included for easier access.

Summary of Findings of the Parks and Facilities Assessment

Access and Comfort Levels

The National Recreation and Parks Association evaluates parks and facilities on their accessibility, level of comfort, and ADA compliance. In these areas of the assessment, the City's level of achievement was evaluated to be high too good for access and comfort. Few needs in this area were expressed by members of the Parks and Recreation Advisory Committee. Greater comfort would likely be improved with a few additional water fountains for sports courts and fields. Some notations expressed a desire for water bottle fillers. Sidewalks and bicycle racks were widely available in developed parklands. Few parklands were noted by committee members as needing more shade. Good access was also supported by the responses of citizens in the Citizen Survey.

ADA Compliance

The City has continued to strive to provide greater access for the disabled in providing paved ADA parking spaces and ramps within all paved parking areas at parks and facilities throughout the city. Complete ADA compliance is not required for all parks if a similar amenity is offered at another park. Despite this allowance, the city has continued to make progress in upgrading its facilities to supply ADA access. Greater sidewalk access within developed parklands, benches with transfer pad areas, and many picnic tables are now geared toward disabled access. However, natural parks without paved parking face challenges in providing ADA parking.

The department does strive to supply other devices to promote accessibility in these natural park areas. Mobi-mats and beach wheelchairs are offered, and a golf cart is available to access areas such as Egan's Creek Greenway.



Maintenance and Safety



In the areas of maintenance and safety, some notations were made by members for improvements with either the condition of a park's amenities, or items that may be in need of replacement. Any safety items were immediately referred to the department for repair or replacement.

Overall, the members of the committee reported the condition of the City's parks and facilities to be in good condition. Most citizens also confirmed this assessment in giving the City's parks and recreation facilities a good to excellent rating for maintenance.

It is to be noted that some of the items reported as concerns in the online assessment reports, on the third page of each park facility, have already been resolved. However, other concerns, such as further ADA access, worn amenities requiring expensive upgrades may be expressed elsewhere as goals or objectives in the Action Plan located in the Implementation Section or in the Recommended Comprehensive Plan: Goals, Objectives, and Policies Section.

Section 3: Needs and Priorities Assessment

3.01 Duplication of Services Assessment

In a review of the 2015 Parks and Recreation Master Plan, the Parks and Recreation Advisory Committee (PRAC) noted a statement by the consultant concerning the department's possible duplication of recreational services in competition with private entities and other agencies in the community. Noting this concern, and the need to comply with Florida statutes, PRAC also collected recreational activity information from other nonprofit and private sector providers in our community (Appendix A). The following information attempted to evaluate overlapping recreational opportunities offered by the city's Parks and Recreation department, private entities, and the nonprofits located within the city limits and its environs.

Florida Statute 163.3177 (6) (e)

(6) In addition to the requirements of subsections (1)-(5), the comprehensive plan **shall include** the following elements:

(e) A recreation and open space element indicating **a comprehensive system of public and private sites for recreation**, including, but not limited to, natural reservations, parks and playgrounds, parkways, beaches and public access to beaches, open spaces, waterways, and other recreational facilities.

Evaluation of Community-wide Recreation Services

The vertical bars in the graphs below depict the estimated number of recreational opportunities offered by all providers for various recreational activities "indicating a comprehensive system of public and private sites for recreation". The recreational opportunities offered by the COFB Parks and Recreation Department are depicted by the blue bar. The Nassau County School system was removed from this evaluation. Members of the committee felt that the school system did not offer recreational activities to the public.

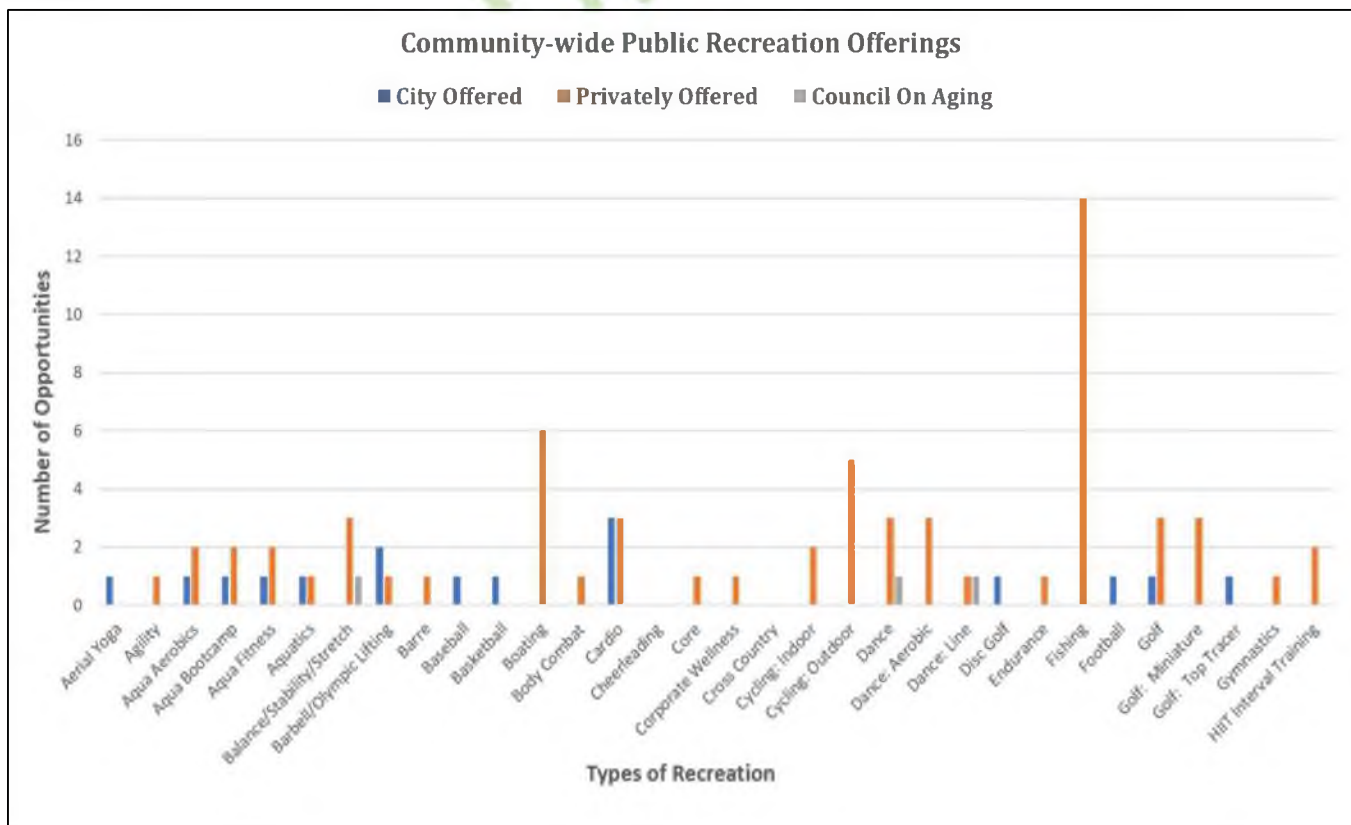
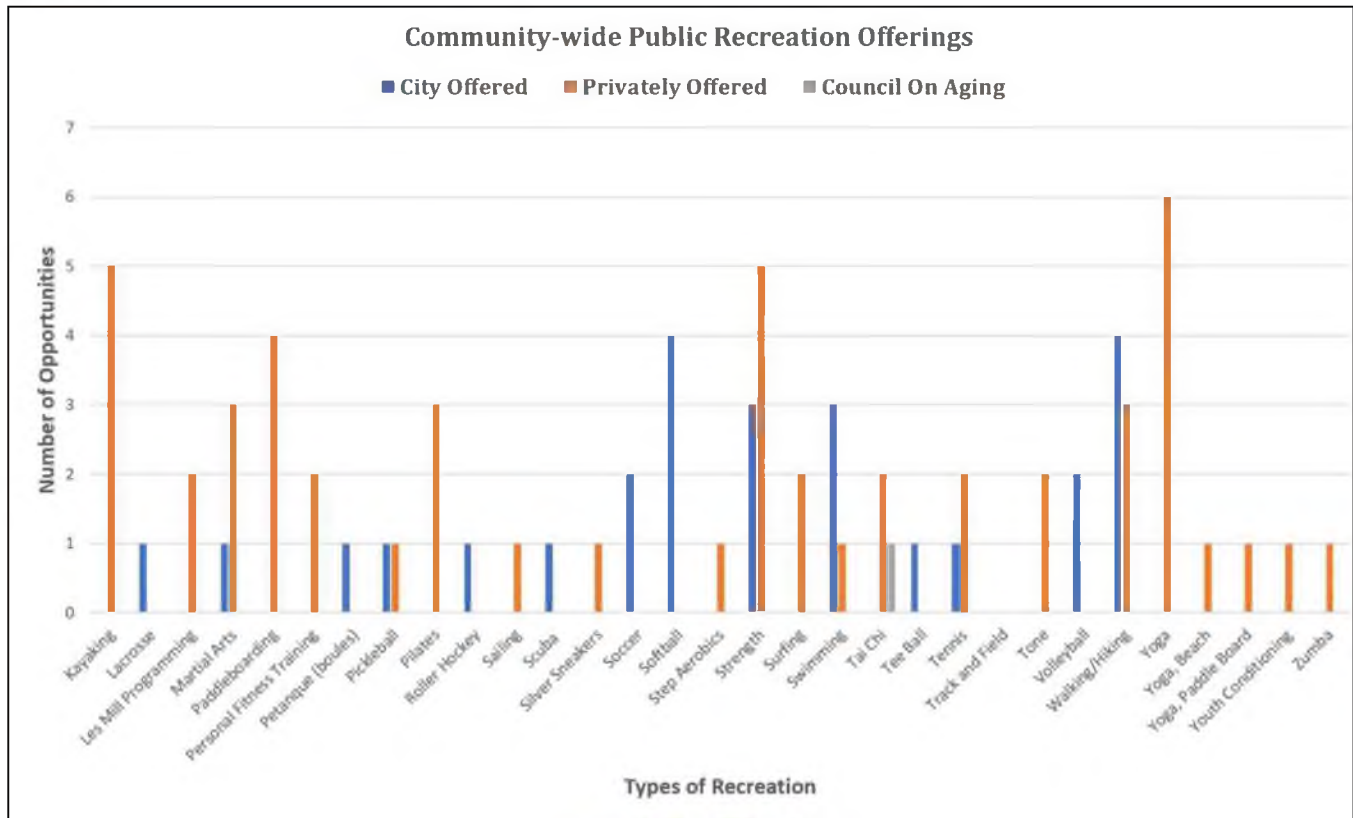

Duplication of Service: Summary of Findings

Lengthy committee discussions provided the following conclusions concerning how to ascertain the unnecessary duplication of a recreational service within the community:

- If department offerings were financially worthwhile to fund an activity's costs, the city should consider keeping the offering despite the duplication of a recreation service offered in the private sector.
- The committee did not have enough data to assess the direct or indirect costs of each city offering to assess a recreational activity's financial viability.
- The committee recommended that the Action Plan request the necessary adequate usage and cost data to evaluate the department's recreational offerings and to further assess any duplication of recreational services that may be occurring in conflict with private entities or other agencies.
- Offerings by the Nassau Council on Aging negates the 2015 Master Plan's recommendation of repurposing the City's Dr. Martin Luther King, Jr Center to create a Senior Center.

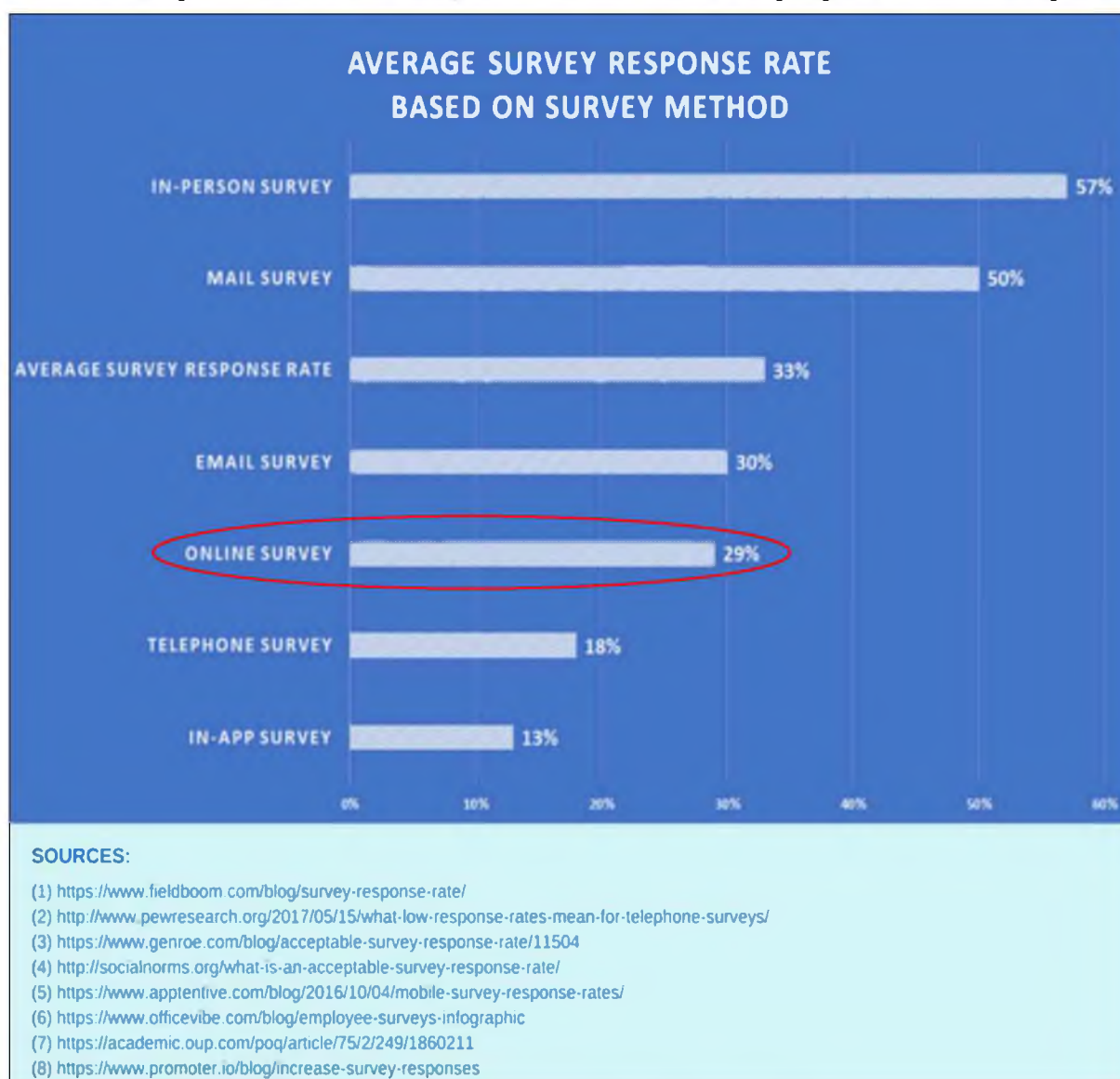

3.02 Public Outreach

Due to the Covid-19 pandemic, an online or written survey became a critical tool in attempting to assess the recreational needs and priorities of the residents of Fernandina Beach. **The previous 2015 Parks and Recreation survey had produced responses from 624 people, 424 were city residents.** Due to Covid concerns, extraordinary efforts would need to be made to gain survey input from the public since public meetings would likely be limited.

Goal Setting

The Parks and Recreation Advisory Committee set a goal for citizen participation of **29% of the City's households**. Based on the most recent U.S. Census population data (5/17/2021), the City of **Fernandina Beach contained 5,631 households**. With two person households as a general norm in Fernandina, a possible outreach to **1,633 households or 3,266 people could be anticipated**.

Outreach Devices

To assist in meeting the goal of receiving 1,633 household responses, for two and half months the Parks and Recreation Advisory Committee and City staff utilized several approaches to reach City residents. A link to the online survey was placed on the City's and the Parks and Recreation websites. The link was shared liberally on social media and placed on Parks and Recreation signage. A paper survey was mailed in utility bills (with various links) and copies were placed at Parks and Recreation facilities.

To further share the link, a QR code and business cards were utilized. A promotional video was shared online.

Outreach Results

After two and a half months, **the outreach produced responses from 1,200 households**. After separating the resident and non-resident responses, **935 City household responses** were able to be utilized for assessing the recreational needs and priorities of City residents.

A participation level of **2,001 City residents** (people) could be estimated when utilizing the City's 2020 Census average of 2.14 residents per household. **243 non-resident households completed the survey** (an estimated 520 people), and 22 households were not able to be identified as resident or non-resident.

3.03 Citizen Survey

To compile the Citizen Survey questions, the committee opted to utilize the questions from the previous 2015 Parks and Recreation Master Plan. In utilizing the same relevant questions, a consistent approach was provided in requesting input from the public. An additional question concerning the cemetery was added to the survey in anticipation of an update to the Bosque Bello Master Plan. The 2021 Citizen Survey questions can be found in Appendix H.

3.04 Citizen Survey Results

Background

All Citizen Survey responses (electronic or paper) were entered into an online Google Form. Despite achieving some uniformity for data collection with online entries, a few open-ended questions in the survey produced many divergent responses on some subjects. All attempts were made to include all responses. However, due to the use of open-ended questions which produced widely divergent responses, responses to open-ended questions were reported in major categories of trends or priorities.

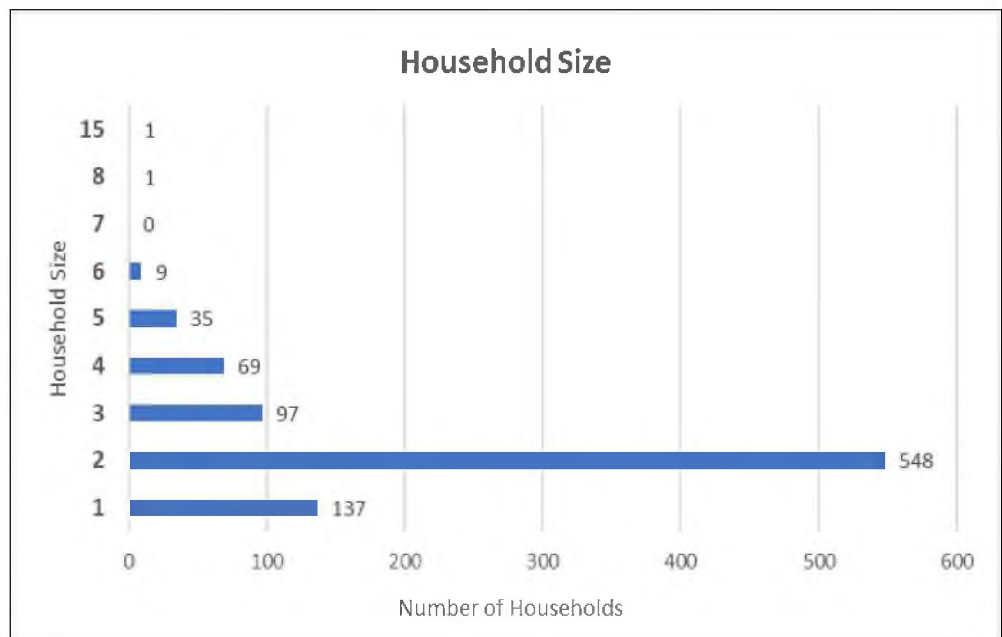
In reporting the results of the survey, a standardized approach was utilized. Each section, at minimum, is depicted with a table displaying the numerical household count to the various responses given to a question, and a corresponding graphic is displayed. **Please note that ALL COUNTS are by HOUSEHOLD.** The response count can be estimated to be higher in utilizing a 2-person household count method. The 2020 U.S. Census reports an average of 2.14 City residents per household.

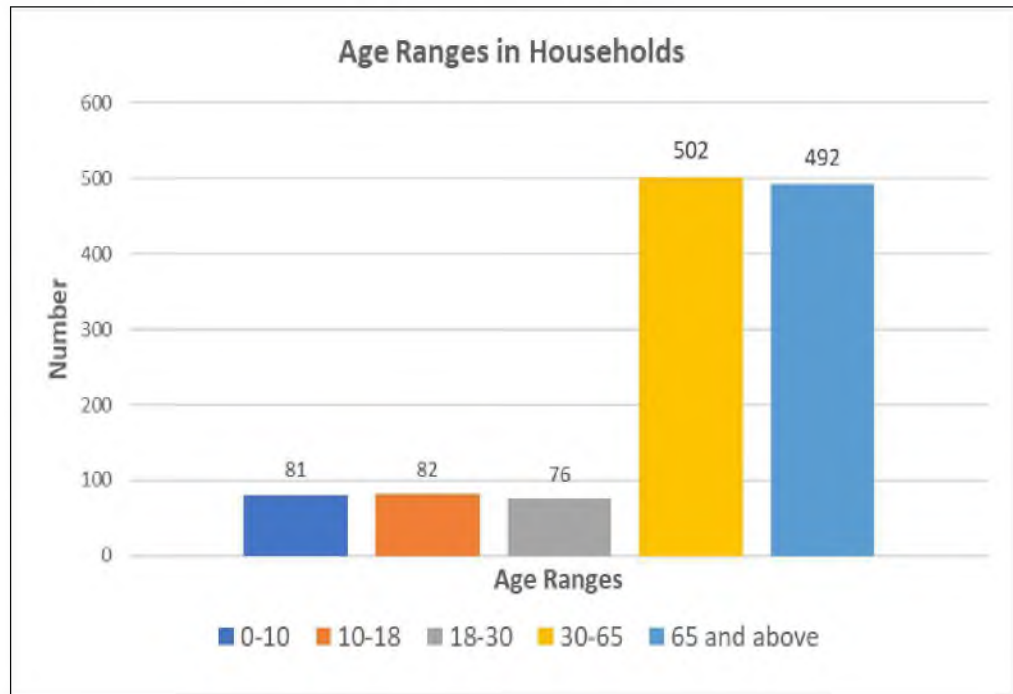

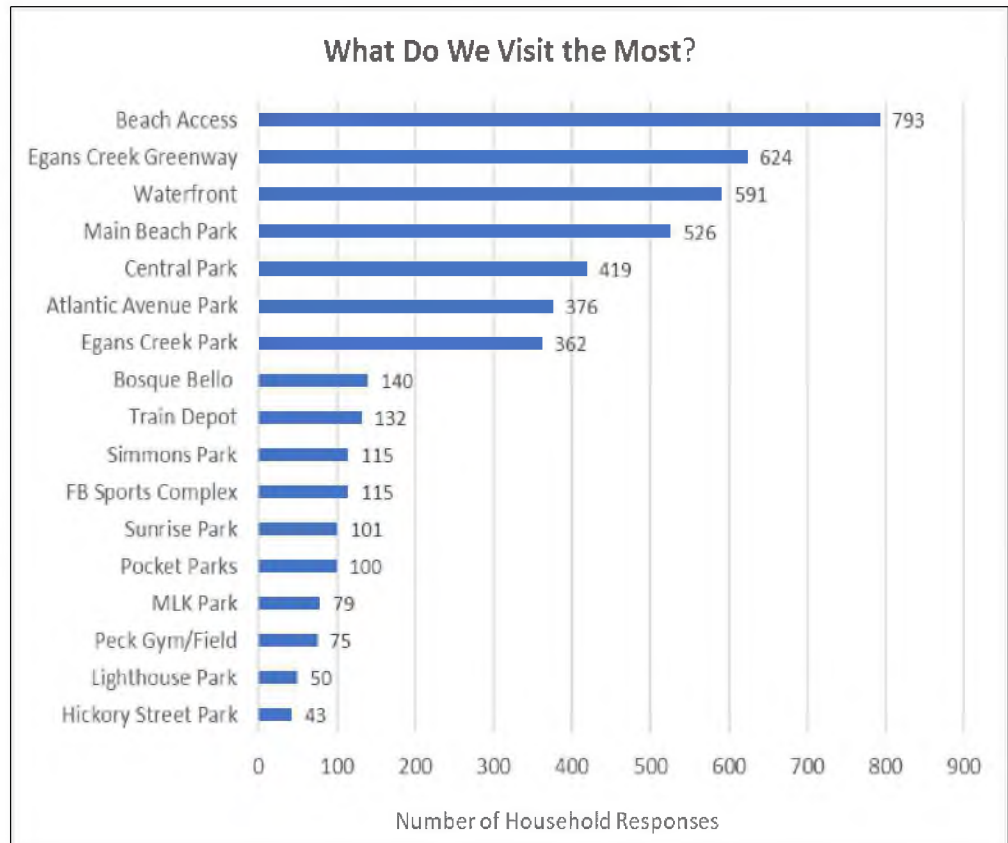

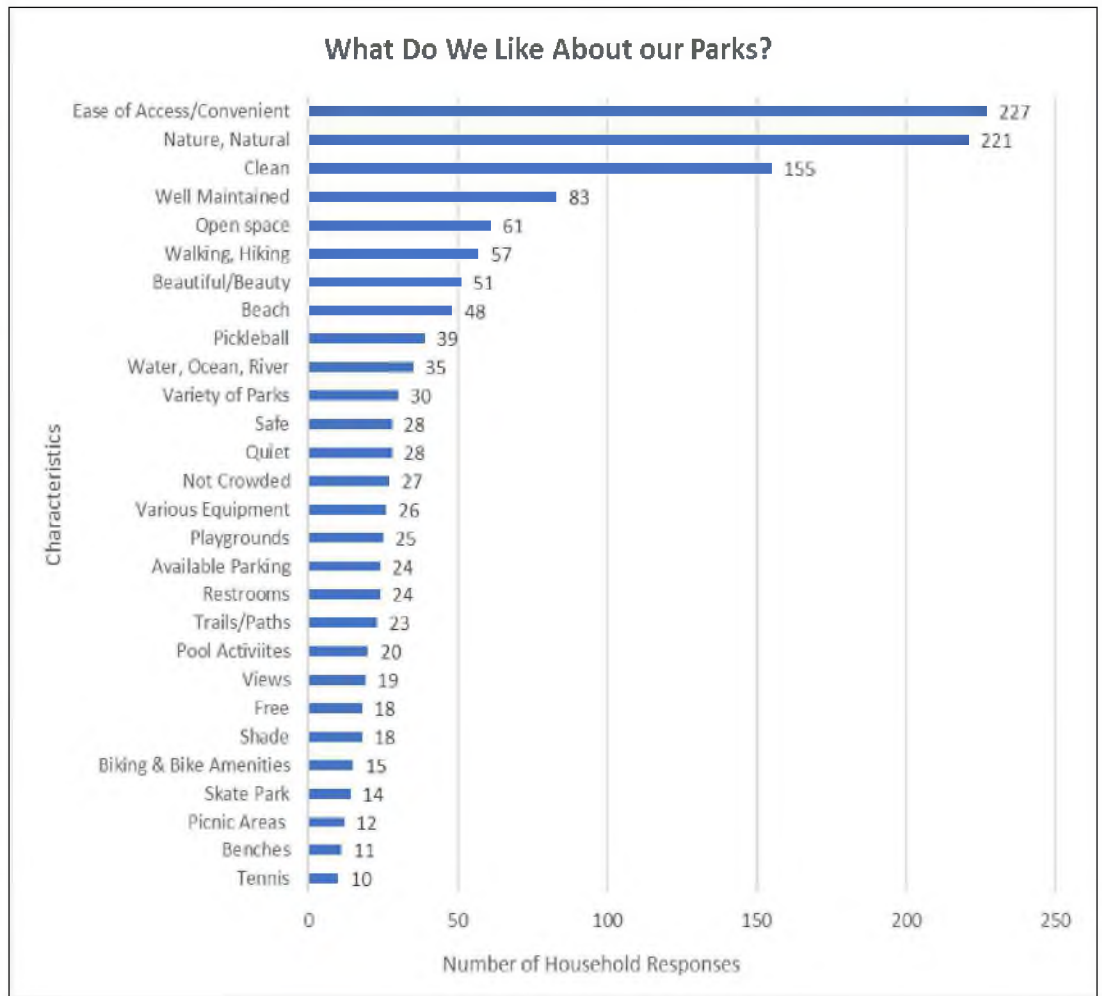

Question 4: What do you like most about the parks you visit?

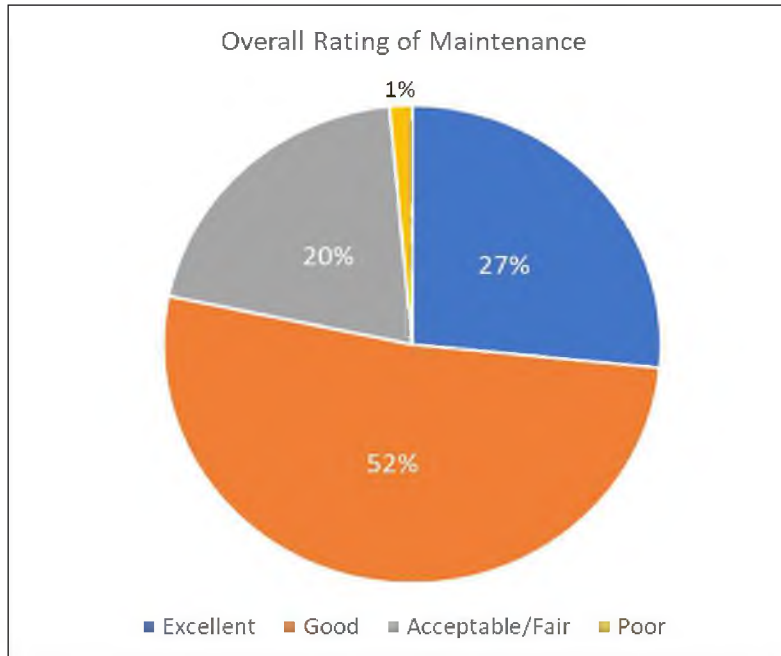

Question 5: How would you rate the level of maintenance of the City's parks, recreation facilities, and open spaces?

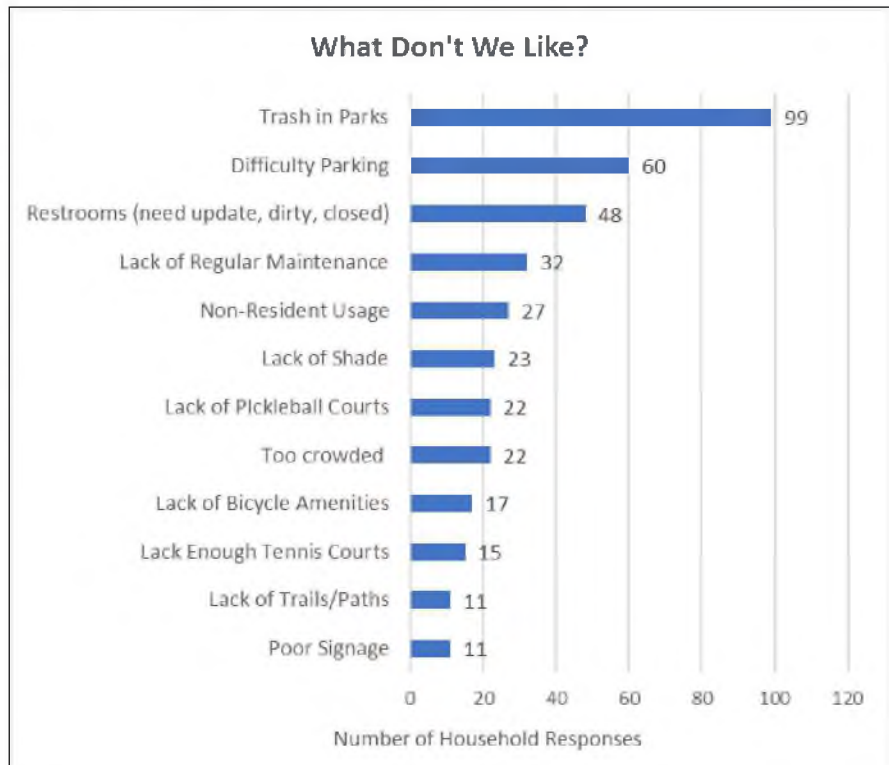

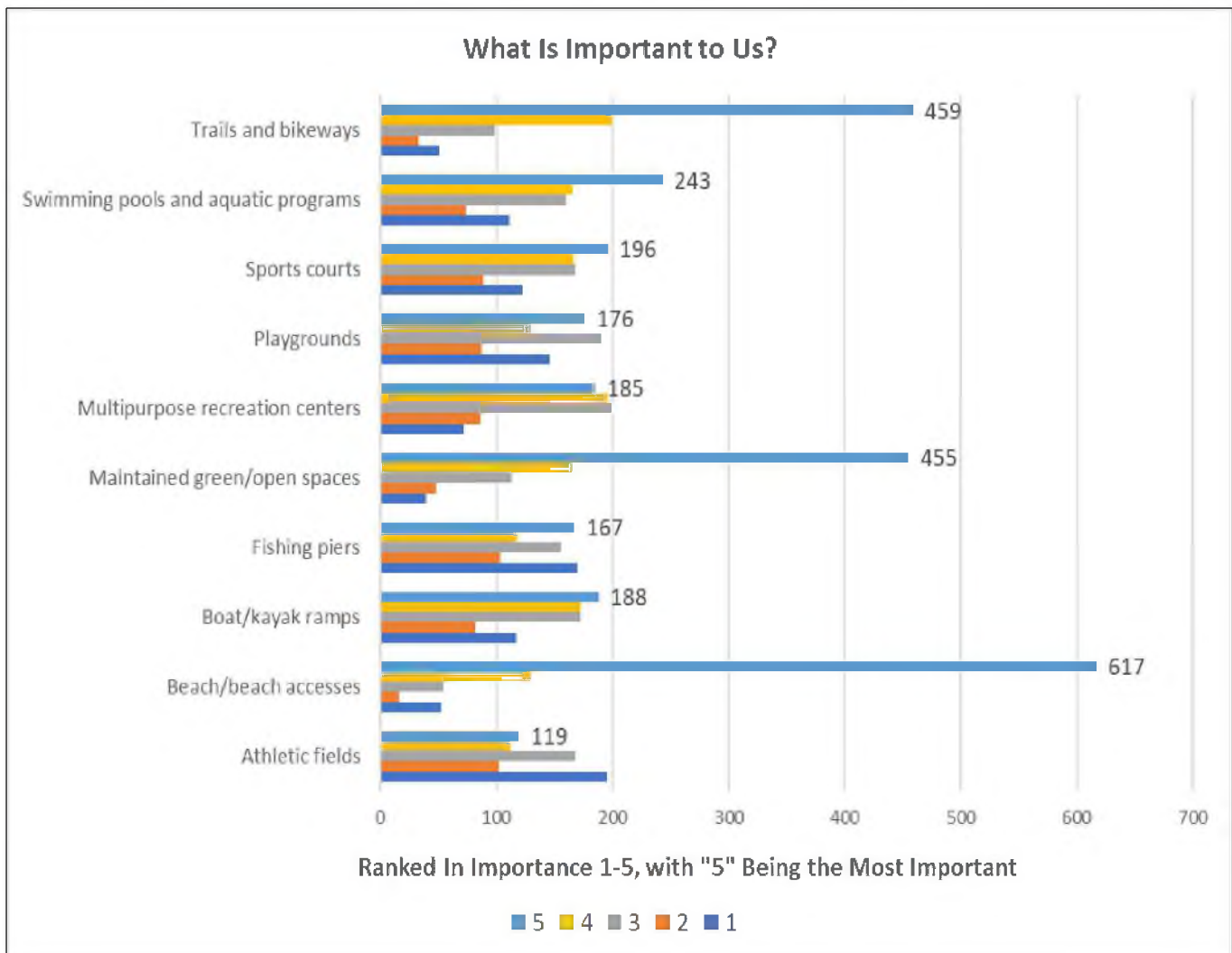


Question 7: What types of parks and recreation facilities and open spaces are most important to you? Rank them 1-5, with 5 being the most important.

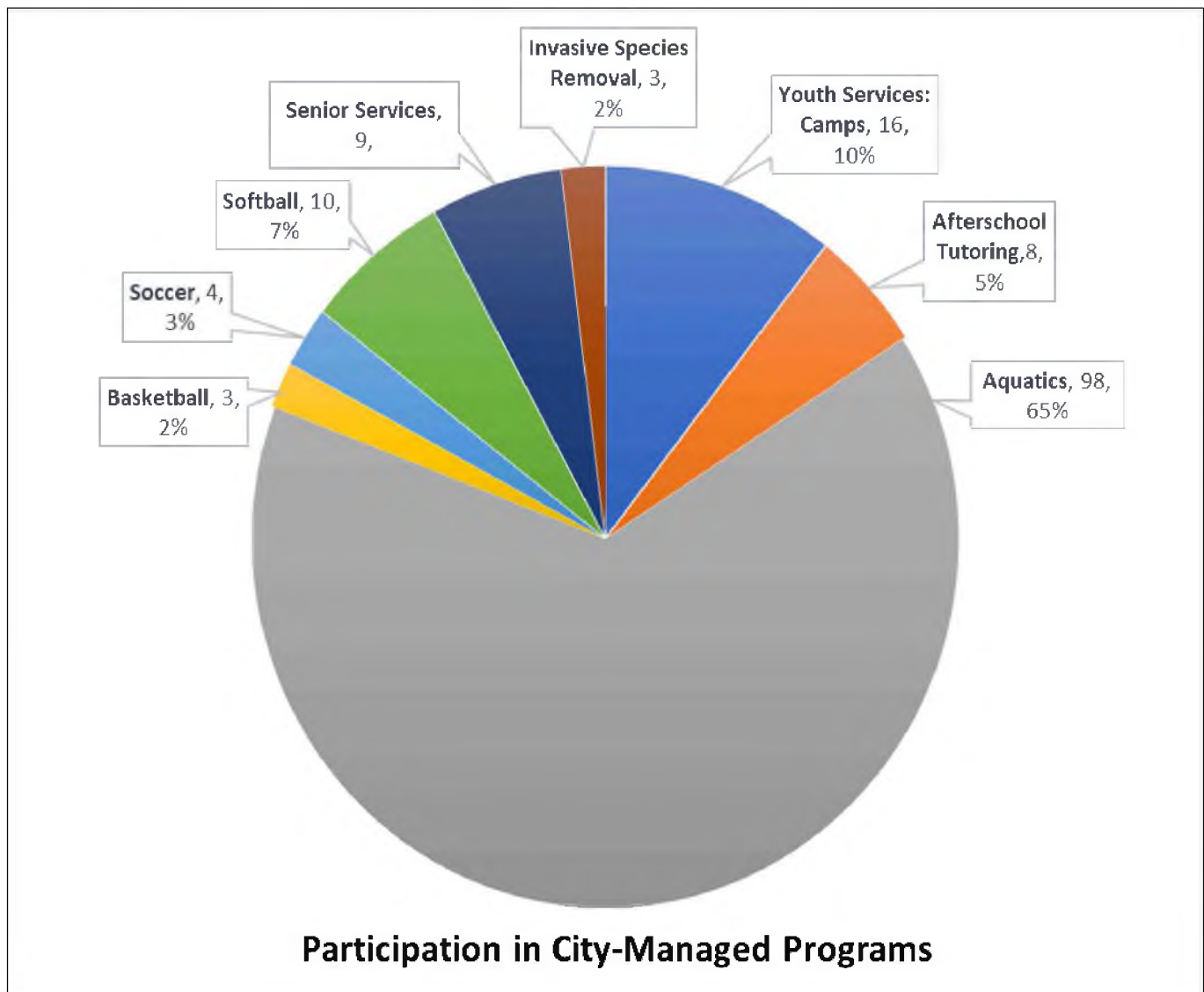

The usage of the City's pools, aquatic fitness classes, and swim lessons produced the largest amount of usage of activities and programs solely managed by the department.



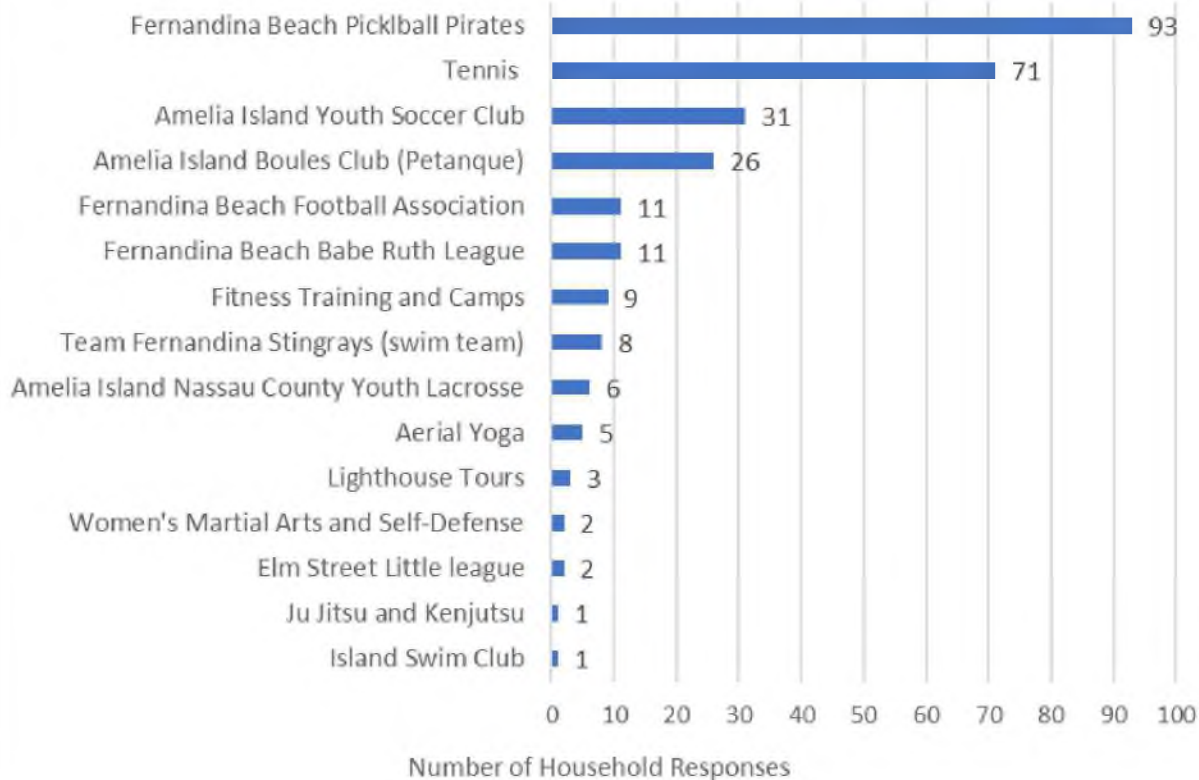

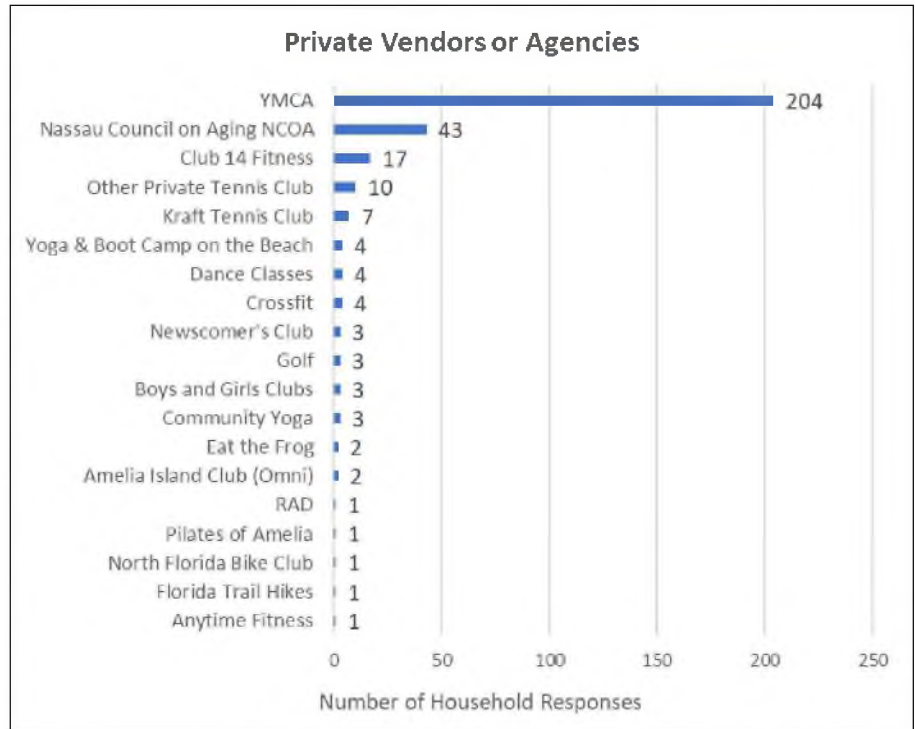

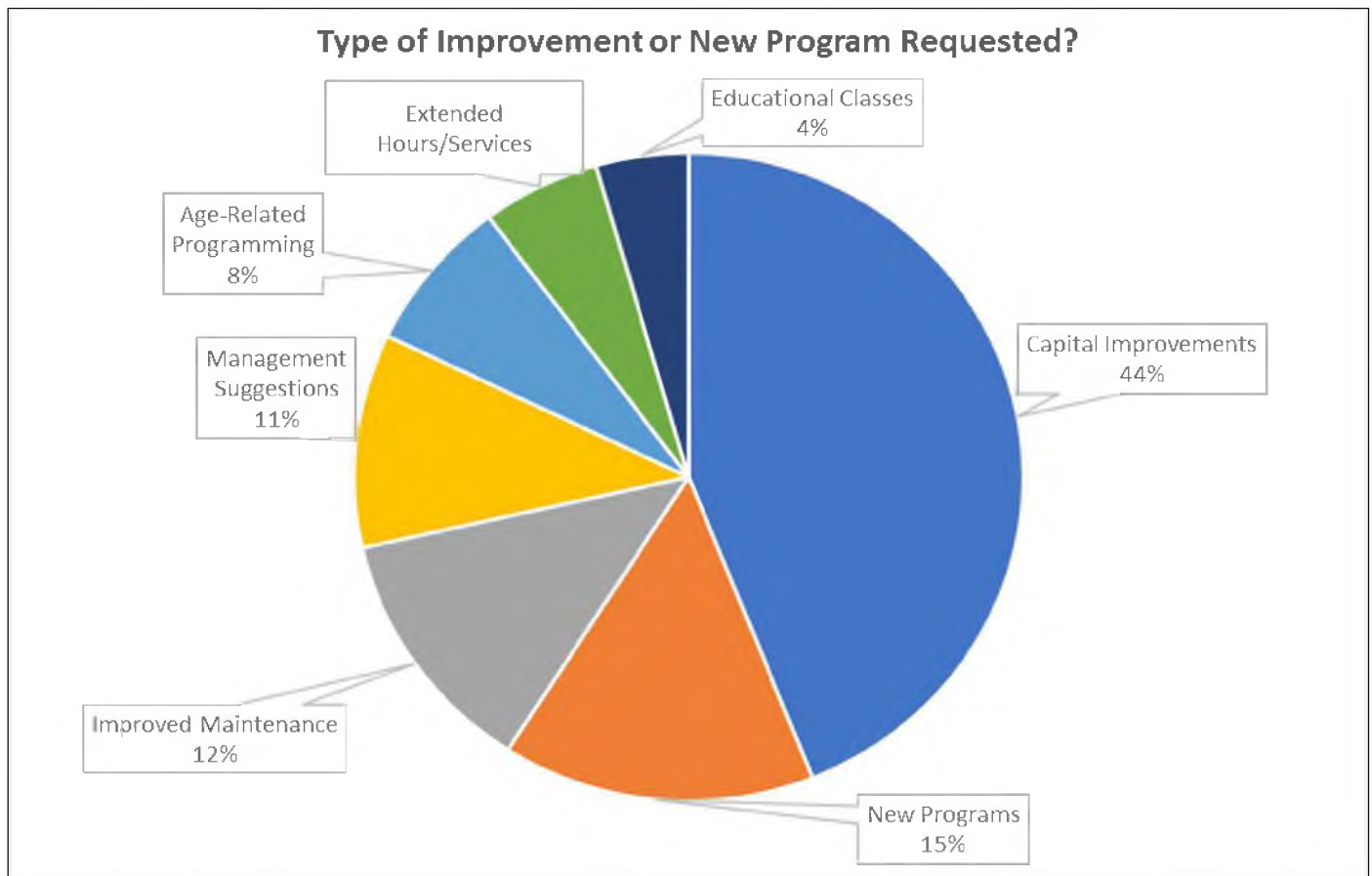

Question 11: What improvements or new programs should be added to the City Parks and Recreation Department?

This question elicited the most diverse responses from any of the questions in the survey. As an open-ended question, **no group of more than 5% of the citizenry requested an agreed upon, single improvement to add to the department.** Though most requests focused on some type of capital improvement (construction and/or replacement), **none emerged as a community-wide request.** A significant number requested continued improvement in the maintenance of the existing parks and facilities, another offered management suggestions such as not adding anything more to the department. Due to the openness of the question, there were many singular responses.

Due to the widely divergent nature of the responses, the **largest types of requests** were depicted in the pie graph below. Data located below the pie graph focused on the top requests for Capital Improvements, New Programs, Age-Related Programming, and Management Suggestions. 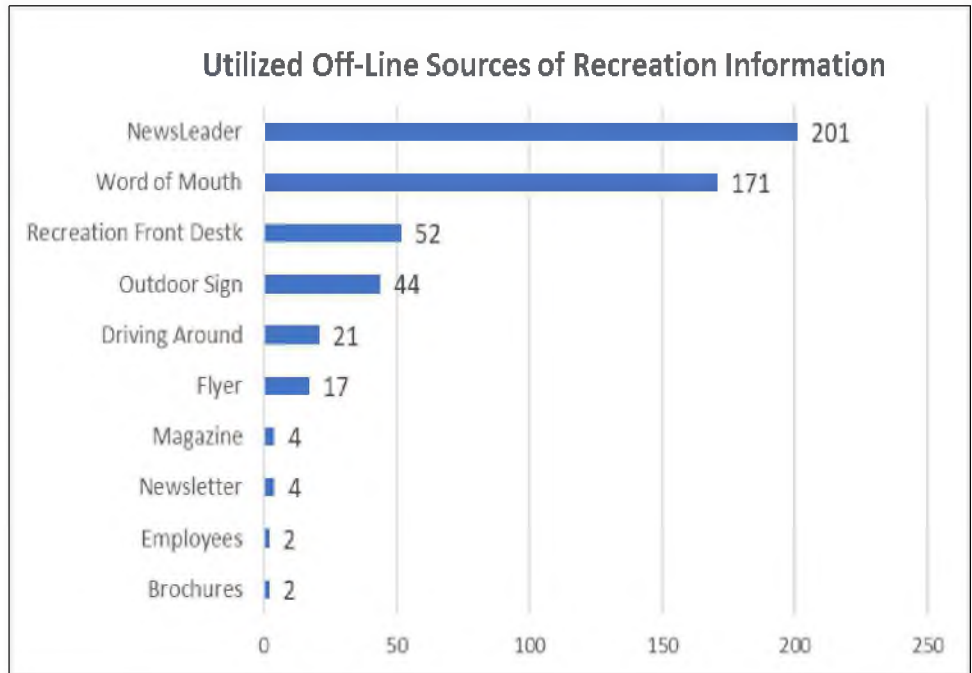

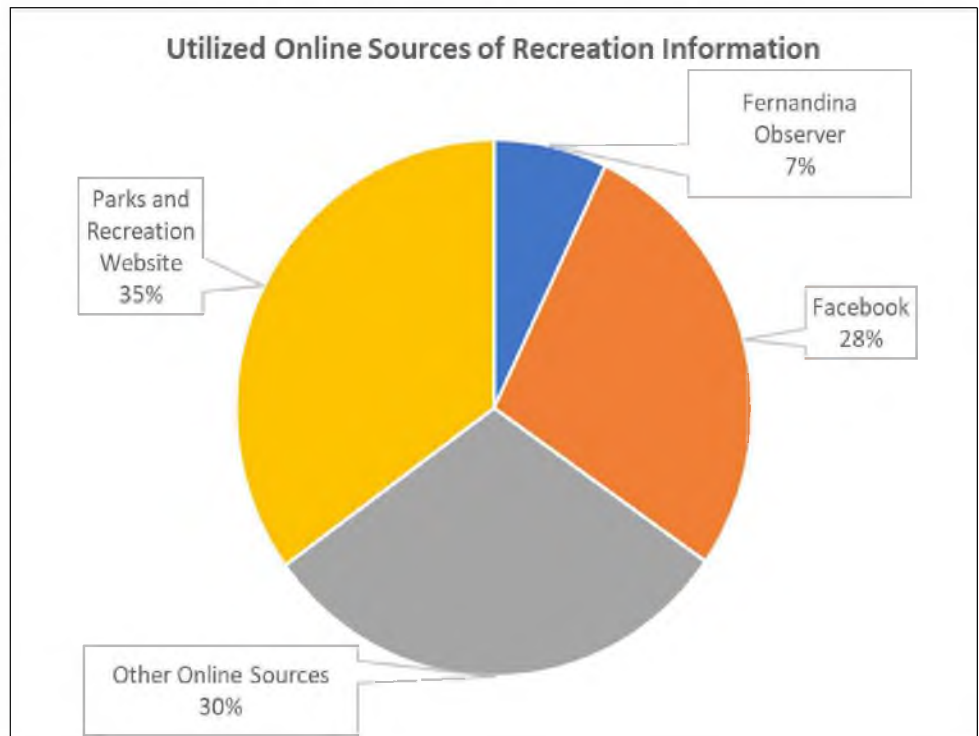
Question 12: How do you find out about the parks and recreation facilities and programs offered by the City?

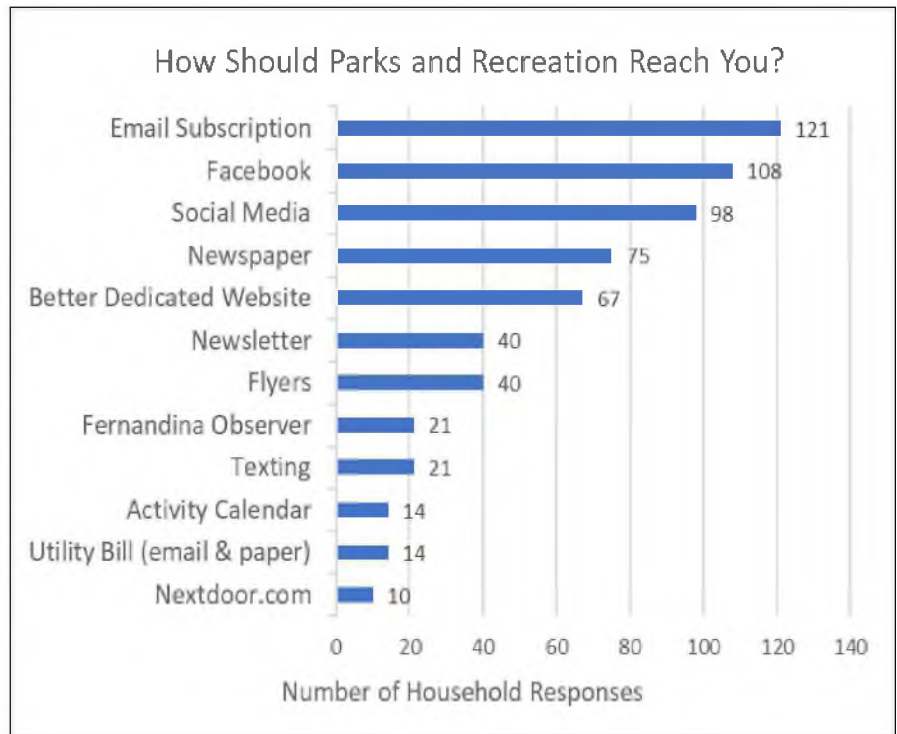

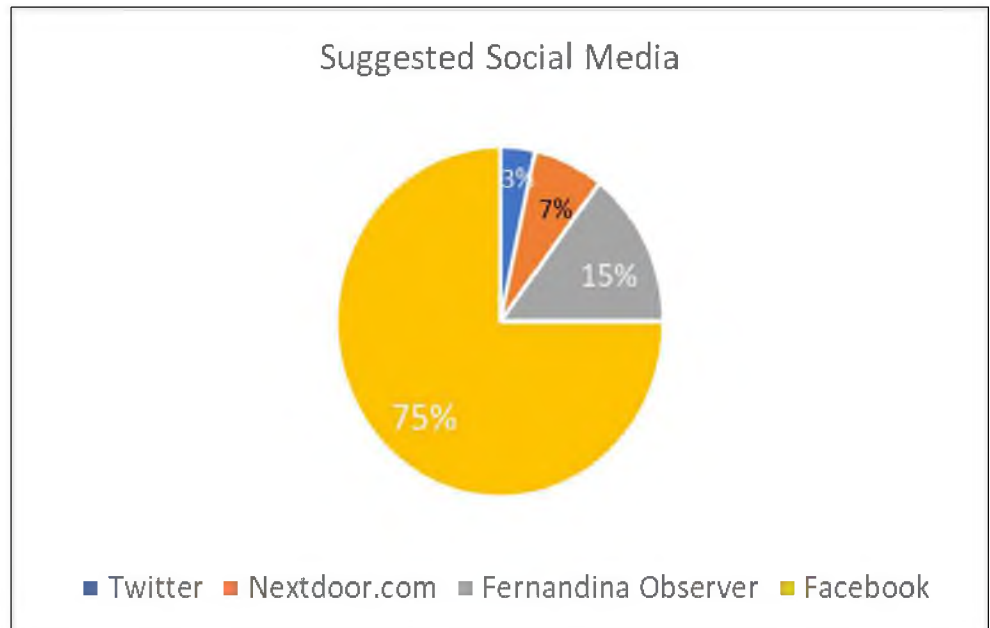
Question 13: How could the City communicate to residents about parks and recreation opportunities more effectively?

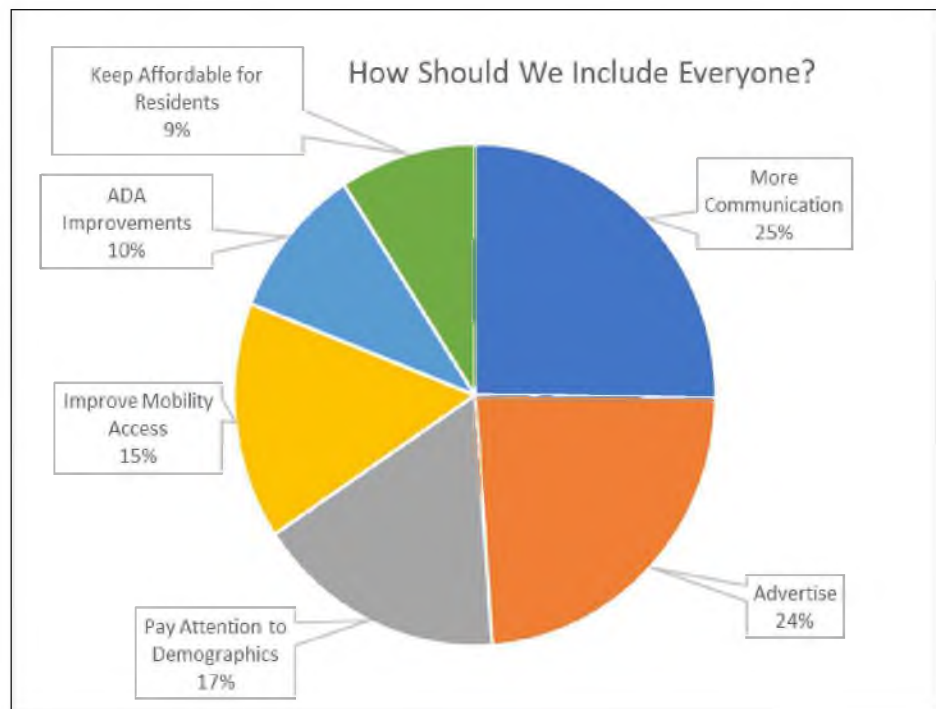

Question 14: How could the City improve opportunities for residents of all ages, genders, and abilities to participate in parks and recreation programs and facilities?

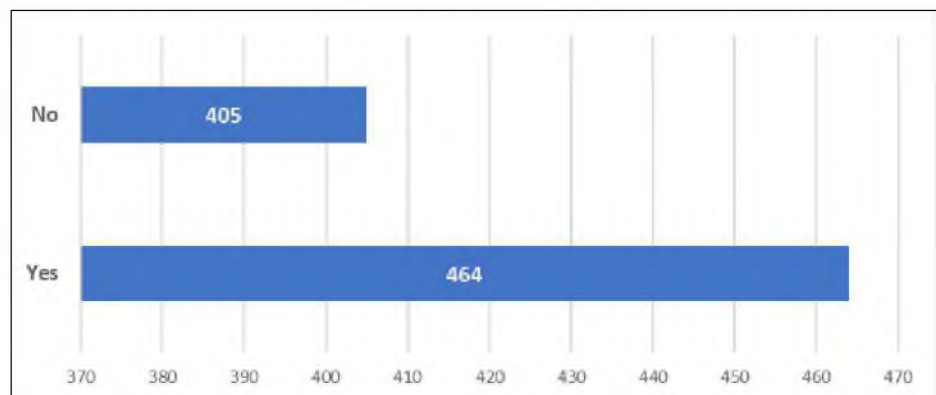
Of all of the questions in the survey, this question evoked the least number of responses. Though limited and diverse in nature, most responses focused on finding ways to better communicate the department's offerings to residents. Some specifically focused on more advertising through social media and the newspaper. They also seemed to focus on a need to further meet the needs of specific age groups' needs. Some recommended that the department increase ADA access. Increased mobility and access, such as more walking paths and bike paths, safe bike lanes, adding public transportation, and the inclusion of ramps on beach walkovers were suggested. To further the awareness of offerings, respondents suggested that the department offer Open Houses, a First Month Free program, send newsletters, improve the website and add a calendar of times and activities such as what is available on the YMCA's website. Some thought that a more collaborative approach could be achieved by reaching out to churches, giving out flyers at schools, approaching colleges to have students teach fitness classes, and talking to the YMCA.

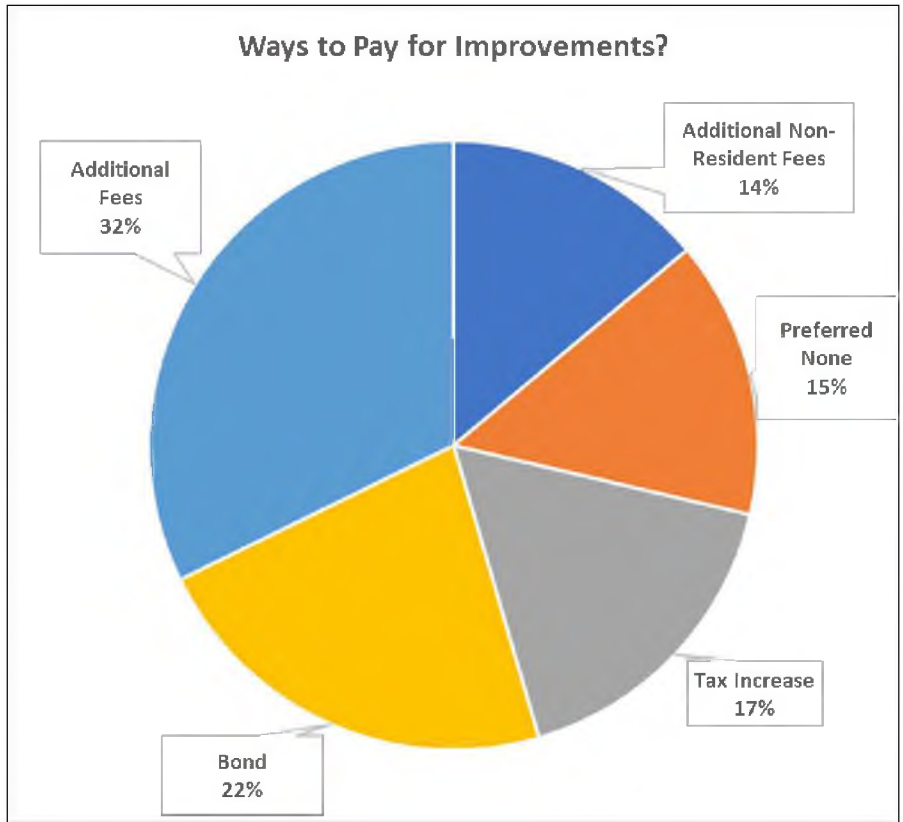
Question 15A: Would you support additional fees, a bond issue, or tax increases to pay for improvements to the City's parks, recreation, and open space system? (1/2)

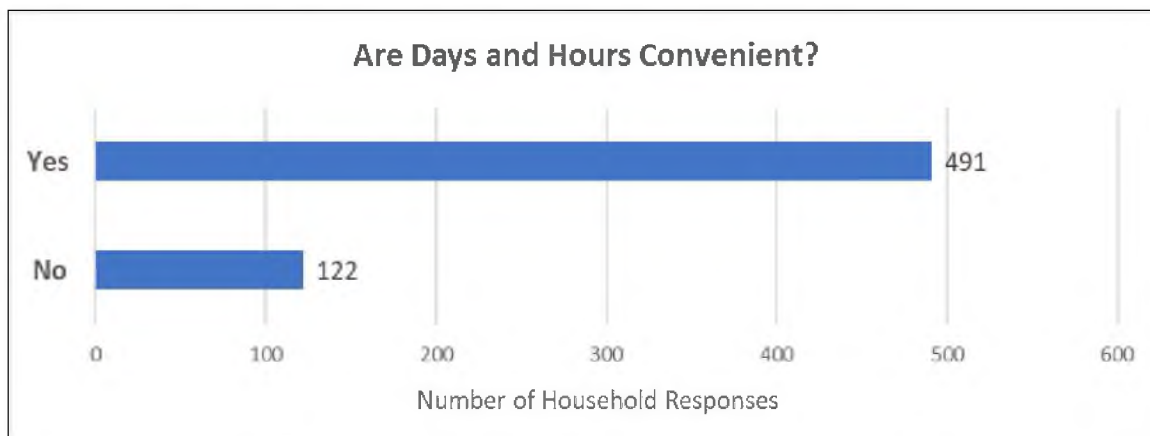


Question 15B: Which method do you prefer? (2/2)

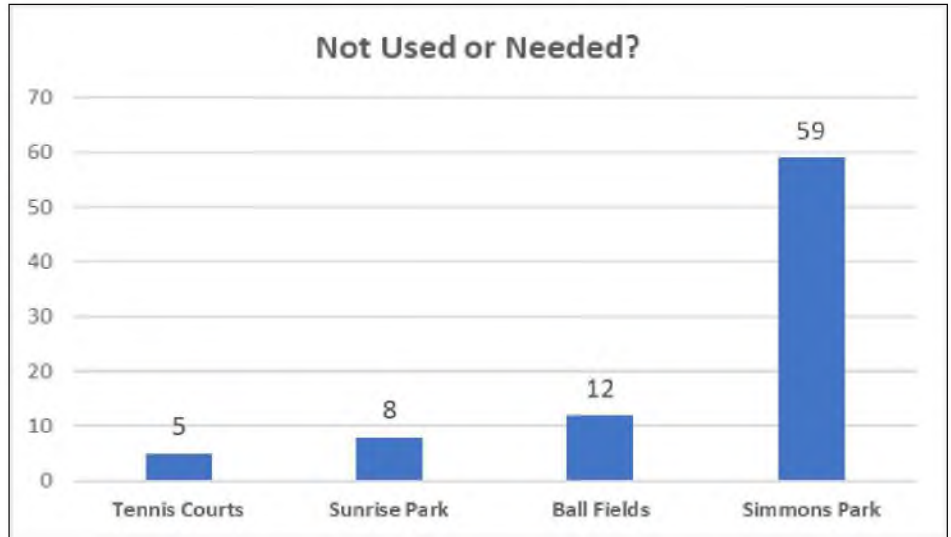

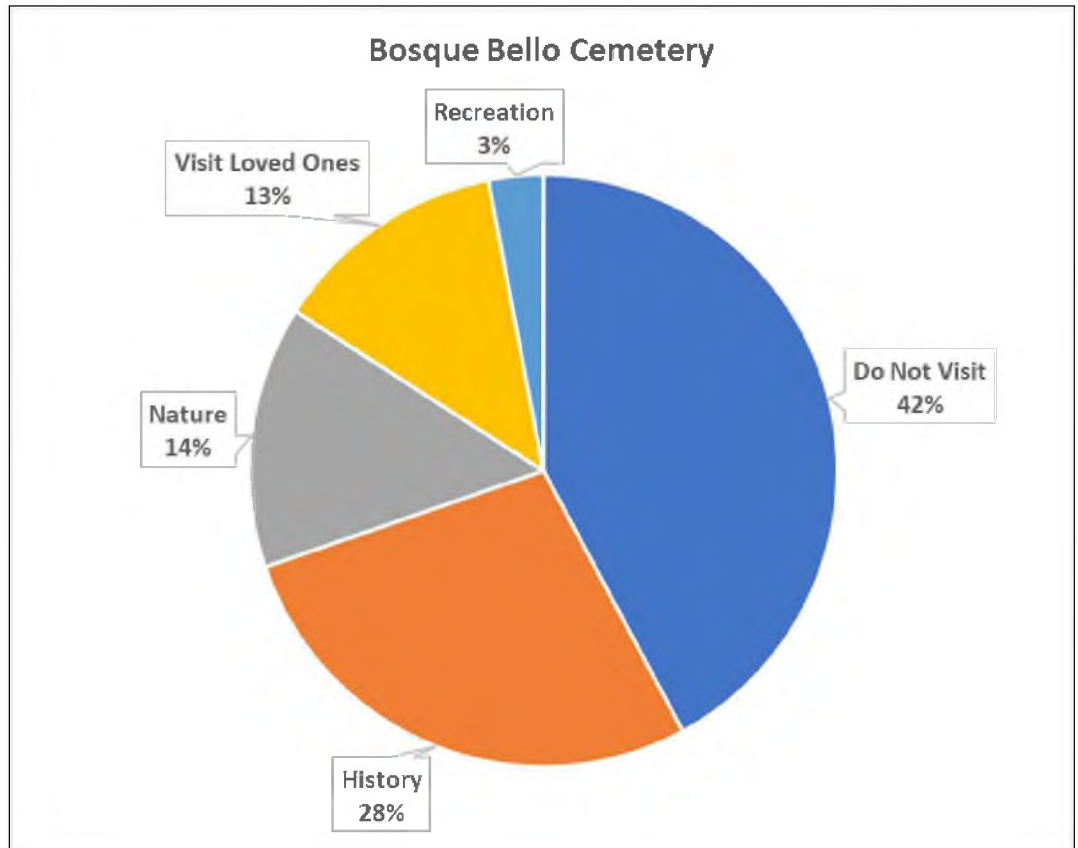


Question 18: Do you visit Bosque Bello Cemetery? If so, why?

Section 4: Long Range Parks and Recreation Vision

4.01 Parks and Recreation Vision

*Florida Statute 163.3177 (1) The comprehensive plan shall provide the principles, guidelines, standards, and strategies for **the orderly and balanced future economic, social, physical, environmental, and fiscal development** of the area that reflects community commitments to implement the plan and its elements.*

The following sources of information were utilized to compile the Parks and Recreation department's Vision for 2030:

1. Citizen Survey responses.
2. Data from the City's changing demographic and socioeconomic profile.
3. The presently available resources of the Parks and Recreation department's parklands and facilities.
4. Present fiscal restraints of declining Impact Fee funding.
5. The growing seasonal population and increases in tourism populations.
6. The growth of privately offered opportunities for recreation.
7. The population growth rate of neighboring Nassau County.
8. Present fiscal budgetary restraints which require the development of new revenue streams to construct, replace, and enhance the maintenance of, the City's parks and facilities.

Long Range Parks and Recreation Vision Statement

The Parks and Recreation department of Fernandina Beach will continue to strive to provide convenient access to all recreation services and facilities for all races, disabilities, and socio-economic and demographic segments of the city's population. Age-appropriate programming for newly-arrived demographic groups will further encourage social cohesion to enhance and maintain the City's sense of community. Passive utilization and maintenance of the city's open spaces, conservation lands, and greenways will further meet citizens' desires to be immersed in nature, provide additional bike paths and trails, increase opportunities for greater access, and further promote resiliency in protecting undeveloped lands. Additional revenue sources derived from seasonal populations, tourism, state and local governments, and sponsorships by private businesses will provide additional funding to further promote the fiscal security required for the continued maintenance of the City's recreational programming, and first-class parklands and facilities.



Section 5: Implementation Plan

Two guidelines were utilized to construct the Implementation Plan or Action Plan.

1. **Page 66 of the 2015 Master Plan** suggested that the Parks and Recreation Advisory Committee prioritize proposed improvements to the Parks and Recreation programs and facilities. These prioritized improvements should be derived from a list of criteria which may include:
 - a. The top priority needs of city residents.
 - b. Projects that generate economic, social, and environmental benefit for the City.
 - c. Projects that will encourage or strengthen partnerships with other public/private agencies.
 - d. The utilization of leveraged public funds.
 - e. Projects that create high quality, long-lasting facilities that represent the City's values.
 - f. Programs and facilities that will help the City achieve its ultimate parks and recreation vision.
2. **Florida Statute 263.3177 (1)** The comprehensive plan shall provide the principals, guidelines, standards and strategies for the orderly and balanced **future economic, social, physical, environmental, and fiscal development** of the area that reflects community commitments to implement the plan and its elements. These principles and strategies shall guide future decisions in a consistent manner and shall contain programs and activities to ensure comprehensive plans are implemented.

5.01 Action Plan

* Note: All Comprehensive Plan references for Goals, Objectives, or Policies noted below are related to the Recreation and Open Space Element of the City's Comprehensive Plan.

1. To ensure that Parks and Recreation programs and facilities assist with the City's **future economic development** and **fiscal development**:

The Parks and Recreation Advisory Committee

- a. prior to August 1, 2022, will develop a written criteria of an approval process for all new Parks and Recreation programs and facilities as suggested in the 2015 Master Plan.
- b. will request a proportional share of funding based on usage or need of residents and non-residents from the Nassau County Parks and Recreation department, other agencies or private entities prior to the approval of the construction or replacement of new or existing recreation facilities in the City of Fernandina Beach. (Comprehensive Plan Objective 6.11, Policy 6.02.04, Policy 6.06.8)
- c. shall request an annual report in the month of February of the previous year's seasonal population numbers from the Amelia Island Convention and Visitor's Bureau.
- d. prior to April of 2022, shall recommend hiring a staff member to provide the services necessary to create for-profit revenue streams as recommended by the consultant, PROS Consulting in 2019. "Other communities that have a business development person on staff or contract have experienced a 7:1 return on investment — \$7 in outside revenue for every \$1 spent on salary." <https://fernandinaobserver.com/city-news/whither-parks-and-rec-consultant-suggests-changes/>
- e. shall promote the offering of for-profit digital, educational, historical, or ecological videos and tours with links on signage at the beach or other recreational areas frequented by the seasonal population to provide additional revenue for the maintenance of the City's aging recreational facilities, beach walkovers, and acquisition of parkland and conservation lands. (Comprehensive Plan Objective 06.10.08, Policy 6.06.07)

- f. shall request an annual report in the month of March of all Conservation land acquired by the City in the previous year from the Planning Department for future utilization.
(Comprehensive Plan Objective 6.06, Policy 6.06.03)
- g. shall further promote less costly construction and maintenance costs by encouraging the use of *passive* recreational programming within existing and future parkland while maintaining existing sites for active use if needed.
- h. annually, at the recommendation of staff, the PRAC will incrementally suggest to the City Manager and the City Commission reasonable deadlines for the discontinuation of services for non-resident usage of specific programs or facilities to meet the service needs of residents and to encourage future county investment in city or county facilities.
(Comprehensive Plan Objective 6.02)
- i. shall annually encourage the Amelia Island Conference Center and Tourism Bureau to participate in the construction of recreation programming and facilities for the seasonal population.

Parks and Recreation Staff

- a. will begin the process of certification with the National Recreation and Parks Association in December of 2022 which assists with cost controls and provides grant funding opportunities.
- b. shall further promote future *passive* recreational programming within existing and future parkland due to its less costly construction and maintenance costs.
- c. shall provide annually to PRAC, in the month of July, a list of services or facilities utilized by non-residents which could be discontinued for non-resident users due to City resident needs for service.
- d. prior to January 1, 2023, shall provide usage numbers for all recreational services by residency in utilizing a variety of methods for data collection at each usage center. These methods may include (depending on the site):
 - i. Further utilization of card scanners.
 - ii. Installation of counting devices such as beacons or geofencing.
 - iii. Other electronic or manual devices that may also provide sources of revenue.
- e. prior to June 1, 2022, shall provide “cost center” data for recreational parks, services, and facilities which includes:
 - i. Maintenance costs
 - ii. Utility costs
 - iii. Personnel costs
 - iv. Anticipated capital costs or capital investment
 - v. And other general costs associated with the generally accepted accounting of costs.
- f. annually, in the month of March, shall recommend parkland, facility, field, court, and sports fees to assist with the maintenance and capital costs of City recreational offerings.
- g. annually, in the month of June, shall notify PRAC and the City Manager of any under-utilized facility space that may be offered for lease to an outside agency or private entity for recreational use.
- h. will continue to pursue private companies offering reimbursement for fitness and wellness classes to various demographic segments of the population.

2. To ensure that Parks and Recreation programs and facilities assist with the **future social development** of the City's residents:

The Parks and Recreation Advisory Committee

- a. shall annually, in the month of February evaluate the department's programming to ensure community-wide needs are met.
- b. shall annually, in the month of April, maintain and update the City's Parkland Acreage Level of Service which reflects the quality of life desired by the community.

The Parks and Recreation Staff

- a. shall develop recreational programs which promote social cohesion and inclusion utilizing data from the Citizen Survey, usage numbers, and census data.
 - b. shall encourage a growing older population and other age groups to socially interact with the introduction of outdoor games or activities such as:
 - i. chess, checkers, or backgammon in the park.
 - ii. lawn game tournaments such as corn hole, horse shoes, lawn darts, or other social lawn games.
 - iii. "Meet and Greet" opportunities.
 - iv. weekly planned invitational "theme walks", post them in the newspaper and online, such as: I have been to Spain, I have grandchildren, I came from New York, I have more than one dog, etc.
 - v. introduce a "City Newcomers Club" to acquaint newcomers to the city's many recreational activities, parks and amenities.
 - c. shall further develop recreational programs and support the construction of recreation facilities based on future requests for services from the City Commission and the Parks and Recreation Advisory Committee.
 - d. shall support and maintain a determined level of service for parkland acreage that reflects the quality of life desired by the community.
3. To ensure that Parks and Recreation programs and facilities assist with the most efficient **physical development** of recreational facilities:

The Parks and Recreation Advisory Committee

- a. annually, in the month of January, shall request a list of capital improvements to be included in the 5-year Capital Improvement Plan (Comprehensive Plan Policy 6.03.2).
- b. prior to June 1, 2021, shall propose to the City Manager and City Commission that a City-wide bicycle, golf cart, or an alternative mode of transportation study be completed to provide **citizen-requested** safe bike lanes, more walkability, and easier access within the city limits (Comprehensive Plan Objective 6.03.09, Policy 6.04.01, Policy 6.04.03).
- c. shall promote the construction of multipurpose courts (rather than specific use courts) to meet the future diverse needs of court usage when new sport court construction is warranted.

The Parks and Recreation Staff

- a. prior to August 1, 2022, the Parks and Recreation staff shall adopt a suggested future consolidation of services and facilities management plan.
- b. shall promote the construction of multipurpose courts (rather than specific use courts) to meet the future diverse needs of court usage when new sport court construction is warranted.

- c. shall monthly report any expenditure or anticipated expenditure to the Parks and Recreation Advisory Committee over the amount of \$70,000.
- 4. To ensure that Parks and Recreation programs and facilities protect and maintain the City's **environmental** assets:
 - a. The Parks and Recreation department shall plant shade trees adjacent to existing shade structures to lower future maintenance costs and shade structure replacement costs.
 - b. The PRAC and staff shall continue to further prevent the creation of heat islands in the City by maintaining the City's tree canopy and further encourage the planting of trees.
 - c. The PRAC and staff shall promote and encourage the use of pervious surfaces, rain gardens, or other water containment and filtration devices in the construction or replacement of a recreation facility to protect ground water sources which provide sources of safe drinking water.
 - d. The PRAC and staff shall encourage the investment in, and acquisition of, conservation lands for resiliency, flood protection, wildlife habitat, and passive recreational use to enhance the quality of life of the City's citizenry (Comprehensive Plan Objective 6.06, Policy 6.06.03).

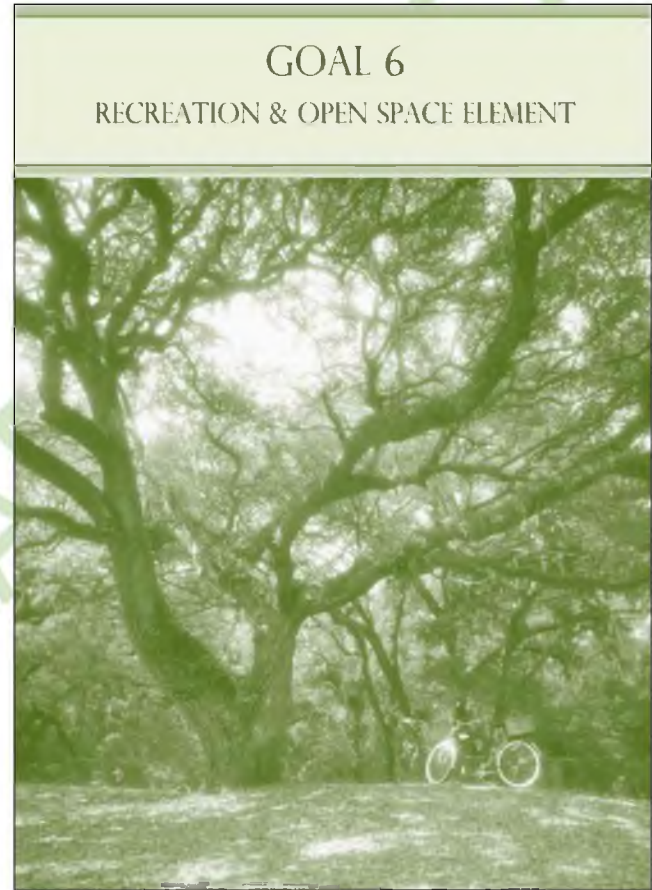
Section 6: Recommended Comprehensive Plan Goals, Objectives and Strategies

Due to the changing needs and priorities of the citizens of Fernandina Beach, this section of the Assessment Plan was compiled to update language in the Comprehensive Plan to reflect changing trends in the field of recreation, and the needs and priorities of City residents. Language changes were noted with strike-throughs and underlined additions to reflect these changes.

Goal 6: Recreation & Open Space Element

Recreation & Open Space Element Highlights

1. Engage in Parks, Recreation and Open Space Master Planning;
2. Maintain an inventory of parks, recreation and open space. ~~based on the Statewide Comprehensive Outdoor Recreation Plan (SCORP);~~
3. Establish equitable distribution of parks to ensure equal access to recreational facilities;
4. Utilize green building standards/sustainable practices for new construction/renovation;
5. Utilize sustainable materials and low-impact development practices in park construction;
6. Plant native landscaping and employ xeriscaping in parks to reduce irrigation, fertilizer and pesticide use;
7. Coordinate to ensure that fleet of vehicles and maintenance equipment is sustainable and energy efficient;
8. Emphasize pedestrian and bicycle access to parks and recreation areas;
9. Identify how open spaces are to be utilized;
10. Identify and map lands for potential acquisition as park or open space;
11. ~~Develop recreational boating needs assessment and assessment of waterways networks;~~ Implement recreational programming which meets the needs and priorities of City residents.
12. ~~Identify shoreline and waterway accesses as part of the overall park and recreational facilities;~~ Continue to develop cost saving and revenue producing strategies to enhance the quality of recreation services in the City.
13. Continue to provide a variety of community services available to the public and continue community outreach and involvement to promote social cohesion; and



14. Address specific resources such as Egan's Creek Greenway and Bosque Bello Cemetery.

OBJECTIVE 6.01.

PARKS, RECREATION, AND OPEN SPACE MASTER PLANNING

The City shall plan for a coordinated parks and recreation system that takes into account access to and availability of parks and recreation facilities and open space areas, the impact of parks and recreation facilities on ecological systems, community education opportunities, and community health.

Policy 6.01.01.

Utilize the City's most currently amended Parks and Recreation Master Plan and the 2021 Parks and Recreation Assessment and Action Plan as a guide for decision-making and planning. The Parks and Recreation Master Plan, prepared by Barth and Associates, dated April 2015 and the 2021 Parks and Recreation Assessment and Action Plan, as may be amended from time to time, is are incorporated by reference into the Comprehensive Plan.

Policy 6.01.02.

The City shall implement the five key elements of the Parks and Recreation Master Plan:

- a. First class parks, recreation and open space facilities and venues,
- b. Improved multi-modal connectivity among facilities and venues,
- c. Equitable access to facilities and venues,
- d. Improved communication regarding parks and recreation offerings, and
- e. Improved design standards and maintenance.

Policy 6.01.03.

Implement the ~~Master Plan~~ City's Assessment and Action Plan, as may be amended from time to time, for existing and future City facilities, which seeks to transform the City's major parks and recreation facilities into first class venues that serve the needs and priorities of the entire community.

Policy 6.01.04.

~~Implement the Master Plan's neighborhood-serving park concept, which seeks to improve access to commonly utilized recreation elements. When feasible, the City shall provide parkland the following for residents within a ½ mile radius from their home to further improve accessibility: shaded playground, multi-purpose open space, sport court, trails, and optional small pavilions and restrooms.~~

Policy 6.01.05.

Update the Parks and Recreation Assessment and Action Plan every five years to track progress ~~to~~ of the five key elements as referenced in Policy 6.02.02 to and make sure ensure that the parks, recreation, and open space system is responsive to community needs.

OBJECTIVE 6.02.**AVAILABILITY OF PARKS, RECREATION FACILITIES, AND OPEN SPACE**

The City shall ensure the availability of parks and recreation facilities and open space.

Policy 6.02.01.

The City shall maintain an inventory of parks and recreation facilities and open space, the identification of recreational facilities available in each park, the size of the facility, and the primary agency responsible for the facility.

The City shall encourage applicants for development approvals, including but not limited to PUD development, to provide recreational facilities and/or open space beyond the minimum standards. ~~by providing for incentives to be included in the Land Development Code.~~ Such minimum standards may include level of service standards or open space percentage or acreage requirements.

Policy 6.02.03.

The City shall add proposed parks, recreation and open space projects, based on the ~~Parks, Recreation and Open Space Master Plan~~ 2021 Assessment and Action Plan to the City's Capital Improvements Plan.

Policy 6.02.04.

The City shall pursue available grant or other funding sources on an annual basis for the acquisition and development of park and recreational areas, including but not limited to, federal, ~~and state, and county~~ funding sources.

Policy 6.02.05.

The City shall on an annual basis, develop, evaluate and maintain existing parks and recreation facilities to meet the needs of the area served, considering the functional capacity of the parks and recreation facilities and the specific requirements of the population served, using the ~~Parks and Recreation Master Plan~~ 2021 Parks and Recreation Assessment and Action Plan as a basis for evaluation.

Policy 6.02.06.

The City shall have a no net loss policy for recreation ~~facilities~~ lands.

Policy 6.03.04.

The City shall not convert, abandon, trade, or sell any park or open space, or portion of park or open space in addition to the limitations established in the City Charter for transfer, sale, or lease of recreation facilities. Open space may be converted to a park, in accordance with Policy 6.05.02, and if ~~the~~ open space levels level of service as established in the ~~Parks, Recreation and Open Space Master Plan~~ 2021 Parks and Recreation Assessment Plan is being met or exceeded.

New parks and recreation facilities, and major renovations of existing facilities, shall be constructed in accordance with Florida statutory requirements that municipal buildings are constructed to meet the minimum requirements of a green rating system.

Policy 6.03.06.

The City shall utilize native plants and xeriscaping techniques when landscaping is added or updated in parks, recreation facilities, and open spaces.

Policy 6.03.07.

The City shall utilize low-impact development strategies to reduce stormwater runoff from parks and recreation facilities.

Policy 6.03.08.

Where feasible, the City shall seek to reduce the amount of pesticides and fertilizer in maintaining parks, recreation and open space landscapes.

Policy 6.03.09.

The City shall ensure that the parks and recreation fleet utilizes energy efficient vehicles when possible.

OBJECTIVE 6.04.**ACCESS TO RECREATIONAL AREAS**

The City shall ensure the availability of vehicular, pedestrian, and bicycle access to public recreational areas.

Policy 6.04.01.

The City will provide vehicle parking, ADA-compliant parking, bicycle racks, sidewalks, bike paths, and barrier-free access at City-owned parks and recreational facilities.

Policy 6.04.02.

Sidewalks, bicycle paths, multipurpose trails, and/or dedication of lands per such shall be required in redevelopment and new developments to provide safe access to parks, recreation facilities, open space, waterways and shorelines.

Policy 6.04.03.

The City shall ensure sidewalk, crosswalks, bicycle path and/or multipurpose trail access throughout the City to the most-utilized and venue based recreational facilities.

Policy 6.04.04.

All future City owned parks and recreational facilities, including beaches and waterways, shall have direct access on a public street, right of way, or easement.

Policy 6.04.05.

The City shall not vacate necessary existing rights-of-way, easements, walkways, and other properties available for public access to parks and recreation facilities or open space.

Policy 6.04.06.

The City shall seek assistance from volunteers in the City in efforts to promote and maintain City recreation facilities.

Policy 6.04.07.

The City shall ensure that Americans with Disabilities Act (ADA) access and ADA recreation opportunities are available at City parks and recreation facilities and venues.

Policy 6.04.08.

Neighborhood-serving Parks shall be prioritized for placement in areas underserved by recreation facilities and shall be prioritized in capital improvement planning when matching funding from other entities may be obtained. Adding additional neighborhood-serving park components to existing facilities shall be secondary after underserved recreational areas are addressed.

OBJECTIVE 6.05. OPEN SPACE

Open spaces shall be protected within urbanized areas for their aesthetic, health, environmental, and economic benefits. The City shall continue to maintain standards in its land development regulations for the provision and maintenance of open space in the community, including in private developments and publicly owned lands.

Policy 6.05.01.

The City shall continue to include conservation areas on the FLUM.

Policy 6.05.02

The City shall determine uses for publicly-owned open space areas, and shall evaluate the presence of environmentally sensitive lands within an open space. If it is determined that open space has environmentally sensitive lands, the City shall limit activities to passive recreation where it is determined that such activities will not endanger the public health, safety, welfare or environment.

Policy 6.05.03.

Privately-owned open space, such as those within subdivisions or PUD developments, which consists of a conservation future land use or contains environmentally sensitive lands, shall be protected through the acquisition of conservation easements.

Policy 6.05.04.

In order to protect environmentally sensitive coastal dunes and promote public safety, no additional areas, or expansion of existing areas, allocated to parking or driving on the public beach shall be permitted.

OBJECTIVE 6.06.**LAND ACQUISITION**

The City shall maintain a program to continually evaluate the potential purchase of land for parks, recreation, conservation, and open space needs, and shall identify and map potential land for acquisition as recreation or open space.

Policy 6.06.01.

The City shall use City-owned floodplains, conservation lands or environmentally sensitive lands, and other similar areas for passive recreational land, provided that the City determines that passive recreational use of these sites would not endanger the public health, safety, welfare, or environment.

Policy 6.06.02.

The City will give high priority to acquisition of lands in the CHHA and in or adjacent to jurisdictional wetlands for passive recreational purposes, provided that that the City determines that recreational use of these sites would not endanger the public health, safety, welfare or environment.

Policy 6.06.03.

The City will give priority to acquisition of lands that provide access to parks, recreation or open space areas.

Policy 6.06.04.

Whenever possible, new recreational sites should be established with active and passive uses to provide both recreational facilities and to ensure preservation or conservation of environmentally sensitive lands. The City shall identify those recreational sites containing environmentally sensitive lands and limit those

portions to passive use recreation only; where it is determined that passive recreational use of these lands would not endanger the public health, safety, welfare, or environment.

Policy 6.06.05.

The City shall add proposed land acquisition projects, based on ~~the Parks, Recreation and Open Space Master Plan~~ the Parks and Recreation Assessment and Action Plan, to the City's Capital Improvements Plan.

Policy 6.06.06.

The City shall seek public and private support for the acquisition, development, operation, and maintenance of parks, recreational facilities and open space areas.

Policy 6.06.07.

The City shall continue to use ad valorem taxes and impact fees to fund the acquisition of parks and recreation facilities. Impact fees shall be reevaluated based on implementation of the Master Plan and any subsequent updates to the Master Plan. Use of other funding mechanisms, shall also be utilized, if feasible.

Policy 6.06.08.

When Impact Fees are not available, acquisition of additional parkland, construction of new facilities, and/or the improvement of access to parks, recreation, and open space areas directly serving new developments shall be funded by new developments in order to maintain level of service standards.

OBJECTIVE 6.07.

BOATING AND WATERWAYS

~~The City shall include boating and waterways in parks and recreation planning efforts by 2017, in conjunction with the Parks and Recreation Master Plan.~~

~~Policy 6.07.01.~~

~~The City shall conduct an assessment of waterways networks, including boating, kayak and canoe trail ways, and other water transportation options.~~

~~The City shall conduct an assessment of existing boating and fishing facilities, including boat ramps, boat repair, fishing piers, and kayak and canoe launches.~~

~~Policy 6.07.03.~~

~~The City shall conduct a boating needs assessment including motorized and non-motorized boating needs, including access points, parking, and other related facilities.~~

~~Policy 6.07.04.~~

~~The City shall adopt level of service standards for boating and fishing facilities, such as boat ramps, kayak and canoe launches, fishing piers, and public access points.~~

Policy 6.07.05-6.07.01

The City shall have a no net loss policy for public access to waterways and shorelines, whereby one type of access point is not removed without providing for replacement of that type of access point.

OBJECTIVE 6.08.

PARKS AND RECREATION COMMUNITY SERVICES

The City shall continue to provide community services through the Parks and Recreation Department.

Policy 6.08.01.

The City shall continue to offer youth recreational opportunities throughout the school year and during the summer when City residents require this service.

Policy 6.08.02.

The City shall continue to offer adult recreational opportunities including classes, leagues, and tournaments.

Policy 6.08.03.

The City shall continue to offer senior services including recreational opportunities and outings.

Policy 6.08.04.

The City shall continue to offer community events and provide educational programming that highlights the importance of health and fitness.

OBJECTIVE 6.09.

BOSQUE BELLO CEMETERY

The City shall protect Bosque Bello Cemetery as a reminder of the community's heritage, and shall maintain the cemetery in a dignified manner while ensuring community safety.

Policy 6.09.01.

The City shall have a cemetery master plan created providing for the long-term viability and care of Bosque Bello, assigning priority to areas in most need of preservation or care. Such plan shall include, but not be limited to:

- a. evaluation of condition and typologies of existing markers, monuments, enclosures and walls;
- b. provisions for the maintenance and treatment of historic markers and walls;
- c. evaluation of existing vegetation, tree canopy, and landscaping;

- d. maintenance, preservation and enhancement of landscaping and the tree canopy in the cemetery;
- e. evaluation of cemetery infrastructure, including structures, site furnishings, irrigation and water, circulation and access, and security; and
- f. provision of recommendations for future maintenance and use of the cemetery.

Policy 6.09.02.

The City shall protect the historic integrity of Bosque Bello cemetery through preservation of the historic section of the cemetery and through protection and maintenance of the vegetation and tree canopy.

Policy 6.09.03.

The City shall make all efforts to provide proper documentation of all markers and maintain records regarding markers and their condition.

Policy 6.09.04.

The City shall incorporate planning for the cemetery into any disaster planning efforts and post-disaster redevelopment strategies.

Policy 6.09.05.

The City shall seek specialized cemetery maintenance training, particularly training related to maintenance of historic cemeteries, for all City staff involved in cemetery operations.

Policy 6.09.06.

The City shall utilize appropriate and proper maintenance techniques for historic cemeteries.

Policy 6.09.07.

The City shall monitor the edges of the cemetery which are adjacent to wetlands for any erosion or damage and take appropriate action should such erosion pose a threat to burial sites.

Policy 6.09.08.

The City shall partner with local and regional organizations to provide volunteer assistance in care and maintenance of the cemetery, including but not limited to, documentation efforts, preservation efforts, and fundraising opportunities.

Policy 6.09.09.

The City shall coordinate with the adjacent mill operator to ensure that industrial uses and operations do not encroach or interfere with the long-term protection of the cemetery.

Policy 6.09.10.

The City shall continue operation of the Cemetery Fund, which dedicates plot sale funds to a Perpetual Fund and to ongoing cemetery operations.

OBJECTIVE 6.10.

EGANS CREEK GREENWAY

The City shall protect Egan's Creek Greenway for its value as a recreational asset, for its significance as an outstanding natural resource, and for its role in providing wildlife habitat.

Policy 6.10.01.

The Parks and Recreation Department shall ensure a management plan is created and updated for the Egan's Creek Greenway including at a minimum ensuring that it is addressed separately in the parks and recreation master planning process.

Policy 6.10.02.

The City shall continue to designate the Greenway as conservation land in the zoning and FLUM series maps.

Policy 6.10.03.

The City shall continue to coordinate with the Florida Department of Transportation (FDOT) on the plan for the restoration of the marshland between Atlantic Avenue and Jasmine Street, Area I. The City shall coordinate with FDOT regarding any impacts of this project on the hydrology south of Jasmine St., Area II, and evaluate the necessity of any restoration plan needs in that area.

Policy 6.10.04.

The City shall continue to encourage the use of the Greenway for walking, biking, and bird watching.

Policy 6.10.05.

The City shall continue to encourage the use of the Greenway as part of the Great Florida Birding Trail and seek inclusion in the Greenway and Trails Network.

Policy 6.10.06.

The City shall continue to conduct ongoing annual plant and animal surveys in order to ascertain any changes in the plant and animal communities of the Greenway.

Policy 6.10.07.

The City shall monitor and control invasive exotic flora and fauna within the Greenway.

Policy 6.10.08.

The City shall continue to provide community-based education about the values of natural spaces, wetlands, endangered and threatened species, invasive species, and human impacts on ecosystems through the use of graphics, tours, online information distribution, and at the Nature Center.

OBJECTIVE 6.11.**INTERGOVERNMENTAL COORDINATION**

The City shall seek to increase intergovernmental coordination regarding parks, recreation, and open space.

Policy 6.11.01.

The City will establish and maintain formal and informal agreements to share facility and program resources with Nassau County, the Nassau County School Board, the state and federal governments, private nonprofit organizations, and others.

Policy 6.11.02.

The City will continue to work with the Nassau County School Board to ensure that new public-school buildings located within the city limits, whenever possible, are co-located adjacent to existing or proposed parks, recreation facilities, open space, and any trail or path system that will connect such facilities to other services such as the library or other community centers.

Policy 6.11.03.

The City will maximize the potential for the collocation and joint uses of public facilities, including the use of public school facilities and the Nassau Council on Aging for recreational, cultural and civic purposes in accordance with the policies in this element.

The number provided by different firms varies in large part to different protocols. Given that, the best figures we can come up with on a average daily basis is between 8,951 and 10,506. That number will change based on monthly demand caused by seasonality. Summer occupancy can run in the 85% range, whereas January will run 55%. I have included monthly occupancy rates for lodging and VBO. Where possible, **the data is FB only.**

For calendar year 2021, Arrivalist can provide granular info. For example, they show 1,032 Adult trips to "points of Interest". 32% of those were day trippers. Downtown FB has received 257,182 trips, Main Beach has had 30,125, and Atlantic Beach 16,423. The average length of stay is 2.5 days. I'm not sure if this is helpful, but available if needed.

I'm going out on a limb, but averages can be misleading. Given a population of FB at around 13,000, during the summer – excluding day trippers – I feel confident that the total of overnight guest comes close to the permanent resident population (Lodging, Vacation Rental, and friends and relatives). Other seasons are significantly less.

We have compiled information from a variety of sources to provide our best answers. I'll source each for your conversations related to validity. Last year's numbers are an anomaly and can be discarded. Any comparisons we need to make will use FY2019 as a baseline.

Lodging & Day Trippers

According to Downs & St. Germain Research, there were 688,700 travelers staying in paid accommodations (Hotels/Resorts/VRBO/B & B). Visitors staying with Friends & Family totaled 239,300 and daytrippers totalled 530,000. Together they total 769,300 visitors per year – over 80,000 people more than lodging guests.

Using other research data (Arrivalist and Research Data) provides much higher numbers. The Arrivalist data, which tracks visitation using information from cell phones, documents some 1,043,594 day trips for the period of October 2020 through June 2021. (Arrivalist excludes those who live in a 25 mile radius. It does not track party size, but rather the number of phones visiting the destination. An SUV with 6 passengers counts as six trip visits.) Research Data Service provides estimates using intercept studies and estimates 1,343,600 day-tripper have visited Amelia Island over the past 12 months (or an average of 3,680 people per day). Please note that some of the difference between these two calculations is likely to be people working on the Island but living elsewhere.

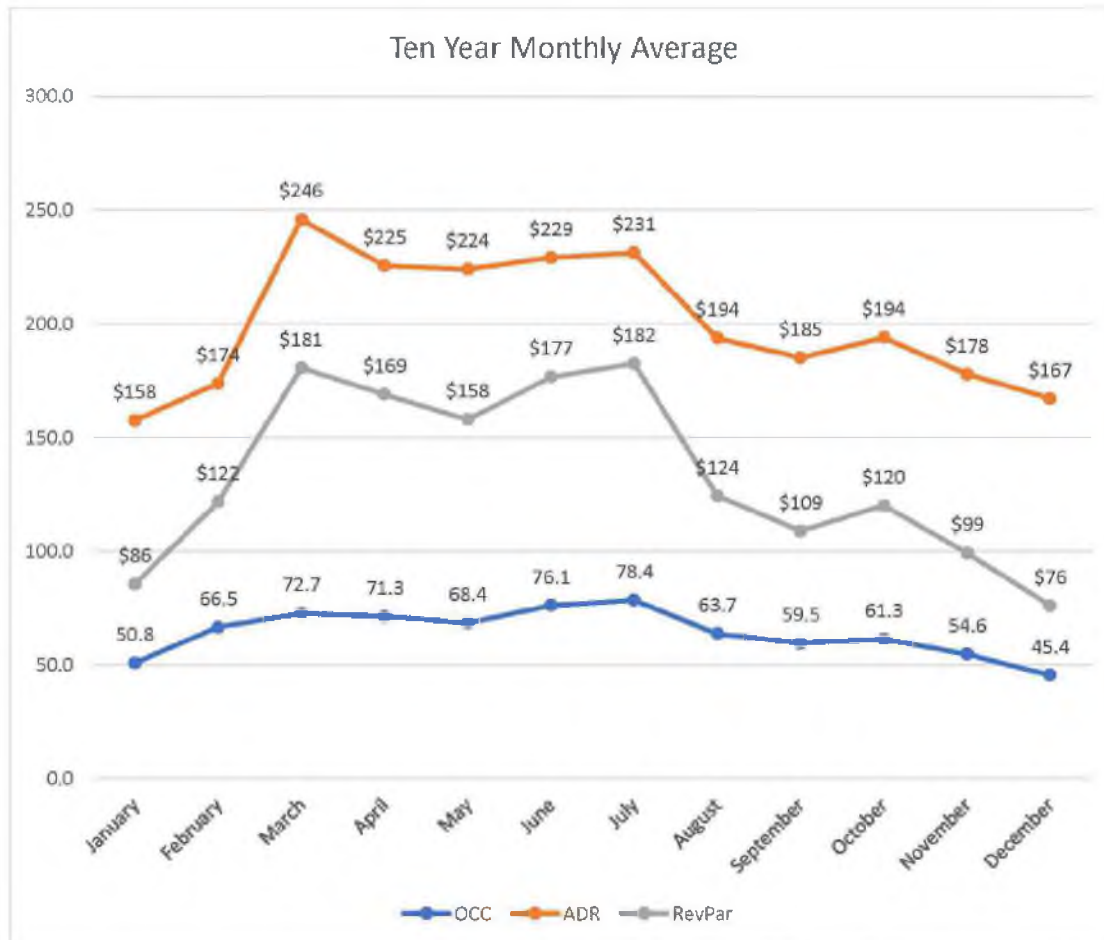
In Fernandina Beach, until May there were 893 rooms in select service hotels and B&B offerings. Occupancy in 2019 ran at 73.4%. Based on an average travel party size at 2.1, the total number of visitors who paid lodging over a 12 month period was 684,484 or 1,875 per night.

With the opening of Marriott properties and the ongoing construction of the Holiday Inn Express in the fall, these 336 rooms bring the total rooms to 1,229 in Fernandina Beach. Using the same research numbers, with the new inventory, paid lodging guests expected in the next 12 months totals 691,145 or 1,893 per night.

Vacation Rentals

We have engaged a new research partner KeyData, which measures Vacation Rental performance. Based on their information there are 820 listings online, including 317 listings on Airbnb; 471 listings VRBO; and 32 listings on both. Using the normal capacity of each unit (3 bedroom sleeps 6 for example) generates the number of “pillows” as the metric. As a new data source, this inventory has yet to be de-duplicated (i.e. listed on both VRBO and AirB&B). Using a figure of 25% for duplicates provides a nightly the resultant performance is as follows:

Average Occupancy 2021: 66%

Projected Nights Rented in 2021: 148,153 (820 listings x 365 x Occ less duplicates)

Projected Pillows Rented in 2021: 896,328 (4,961 pillows x 365 x Occ less duplicates)

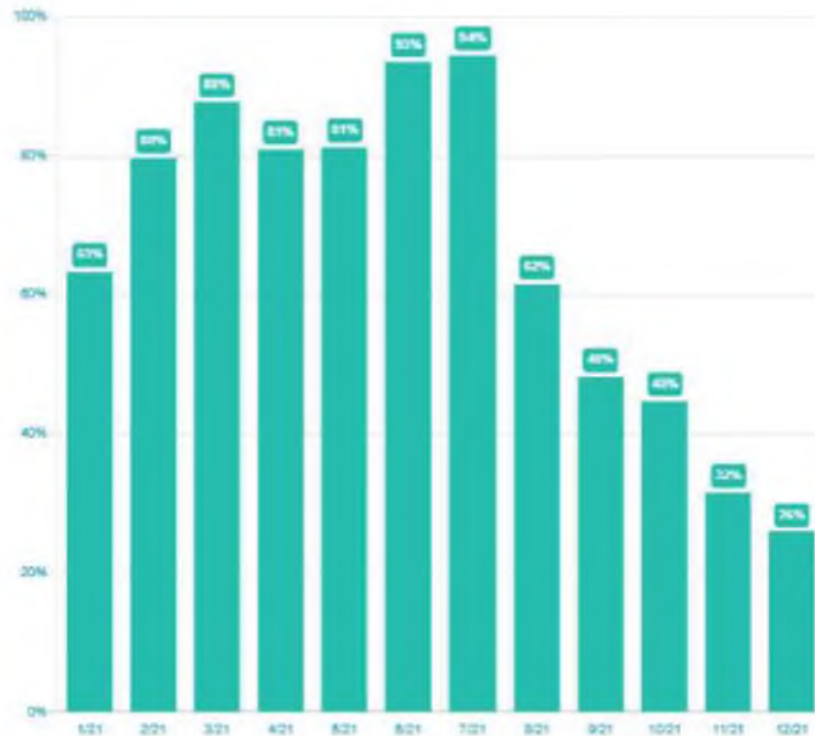

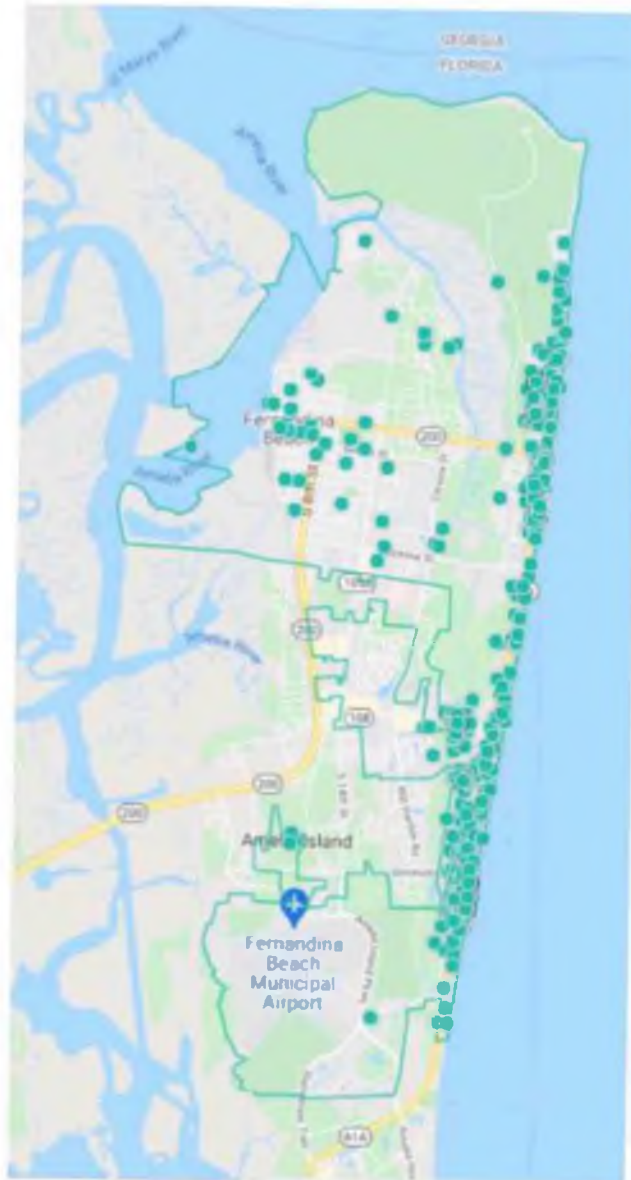
These figures are for Fernandina Beach only. The total number of units in unincorporated Amelia Island is 922 with a capacity of 5,044 visitors per night. Using the same 25% for duplicates provides a nightly capacity 3,783. With a 66% occupancy rate, on any given night 2,496 people are staying in rentals outside of Fernandina Beach city limits.

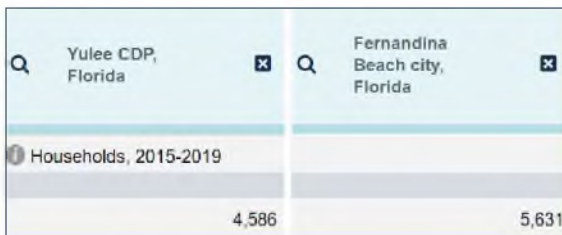
Appendix E: Residential Listings 2017 through 2020

1. What is an acceptable standard for the Parkland Acreage Level of Service?

*“In contrast, parks and recreation system planning has historically been more art than science. Unlike other elements of the public realm, **there are no nationally accepted standards for determining ideal levels of service for parks, indoor recreation centers, athletic fields, trails, and other recreation facilities.** The last set of national guidelines published by the National Recreation and Park Association (NRPA) in 1996 encourages communities to develop their own LOS standards rather than rely on any national standards: “A standard for parks and recreation cannot be universal, nor can one city be compared with another even though they are similar in many respects” (Mertes and Hall 1996, 59). **Each city or county must determine the appropriate LOS required to meet the specific needs of its residents.**”*

2. Which types of lands are to be counted in determining the Parkland Acreage Level of Service?

*“What should be counted in an Acreage LOS?” **Unfortunately, there is no standard answer.** Some communities include public golf courses and beaches, while others include publicly accessible lakes and wetlands. Some cities and counties also include public parkland owned by other agencies, such as state parks and national forests. Some communities also count private recreation areas, owned and managed by homeowner’s associations, because these areas help meet residents’ local recreation needs. Because the primary purpose of Acreage LOS is to measure and monitor a community’s supply of parkland, **it is recommended that communities count only developable, publicly accessible parkland within their jurisdiction. Undevelopable lands such as conservation areas, wetlands, water bodies, golf courses, and beaches cannot help a community meet its needs for parks, playgrounds, athletic fields, open play space, recreation centers, and other basic parks and recreation facilities.** Privately owned parkland is not open to the public, and could be sold or redeveloped. Public parkland owned by another jurisdiction (such as county-owned parks within a municipality) is already counted by that jurisdiction for its own LOS, and should not be included in a community’s acreage calculation.”*

Method used to calculate the City’s Parkland Acreage Level of Service:

- a. Land that met the City’s definition of parkland.
- b. Though not recommended, the City’s beaches were included since 85% of the City’s residents report utilizing the beaches for their recreation (open play space).
- c. Any additional lands which contained a picnic table such as the Greenway (Conservation land), Seaside Park and North Beach Park (which are considered to be beach accesses).
- d. As suggested above by the author, the golf course was not included and is not managed by the Parks and Recreation department.
- e. Acreage amounts were obtained from the online records of the Property Appraiser’s website.

Egan's Creek Greenway, located on the northern end of the island, opened in 2000 as an undeveloped park for conservation and passive recreational use. Funding for the land acquisition was provided by the Florida Communities Trust and the City of Fernandina Beach. Managed by the City's Parks and Recreation Department, the park consists of over 300 acres of protected lands with a variety of natural wildlife and vegetation. The northern end of Egan's Creek, which runs from Jasmine Street to Atlantic Avenue, offers grass covered trails ideal for walking and biking. A nature pavilion and picnic area are located at the Atlantic Avenue entrance along with benches, a boardwalk, education kiosks and an ADA compliant viewing platform. A restroom is available at the Nature Pavilion.

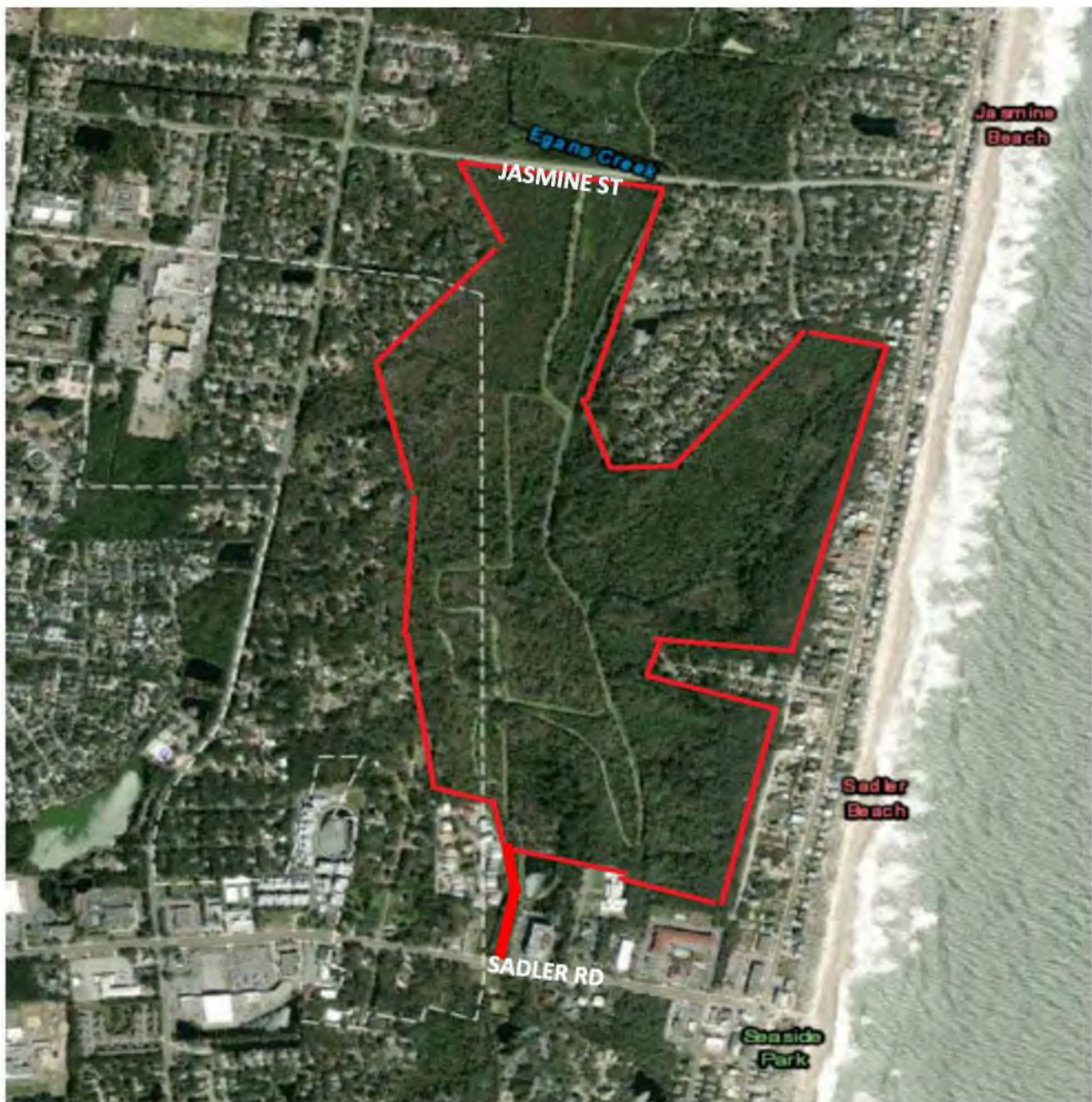

The southern expanse of Egan's Creek Greenway, located between Jasmine Street and Sadler Road, features a grass-covered network of trails suitable for walking and bicycling. Visitors enjoy a more forested, freshwater ecosystem than the Greenway's northern counterpart. Its environment exhibits a variety of natural wildlife and vegetation. Alligators, marsh rabbits, snakes, bobcats, and many bird species may be enjoyed from a distance on its boardwalk or trails. At the end of the street, beach parking is permitted on the stretch of sand in front of the park during specific hours at different seasons of the year. However, amidst all of this bustling activity, the park retains its unspoiled character. Its dunes and vegetation are well protected with a network of walkways which connect permanent shade structures and picnic pavilions. There is easy viewing from the shelters with bench seating. Outdoor showers are located on the connecting beach walkway and at the restroom area. Educational signage can be viewed from the walkways, and a state water quality notification sign can be seen at the entrance of the dune walkover. Bench seating inside the pavilions offers shaded views of the beach, while other pavilions offer picnic tables.

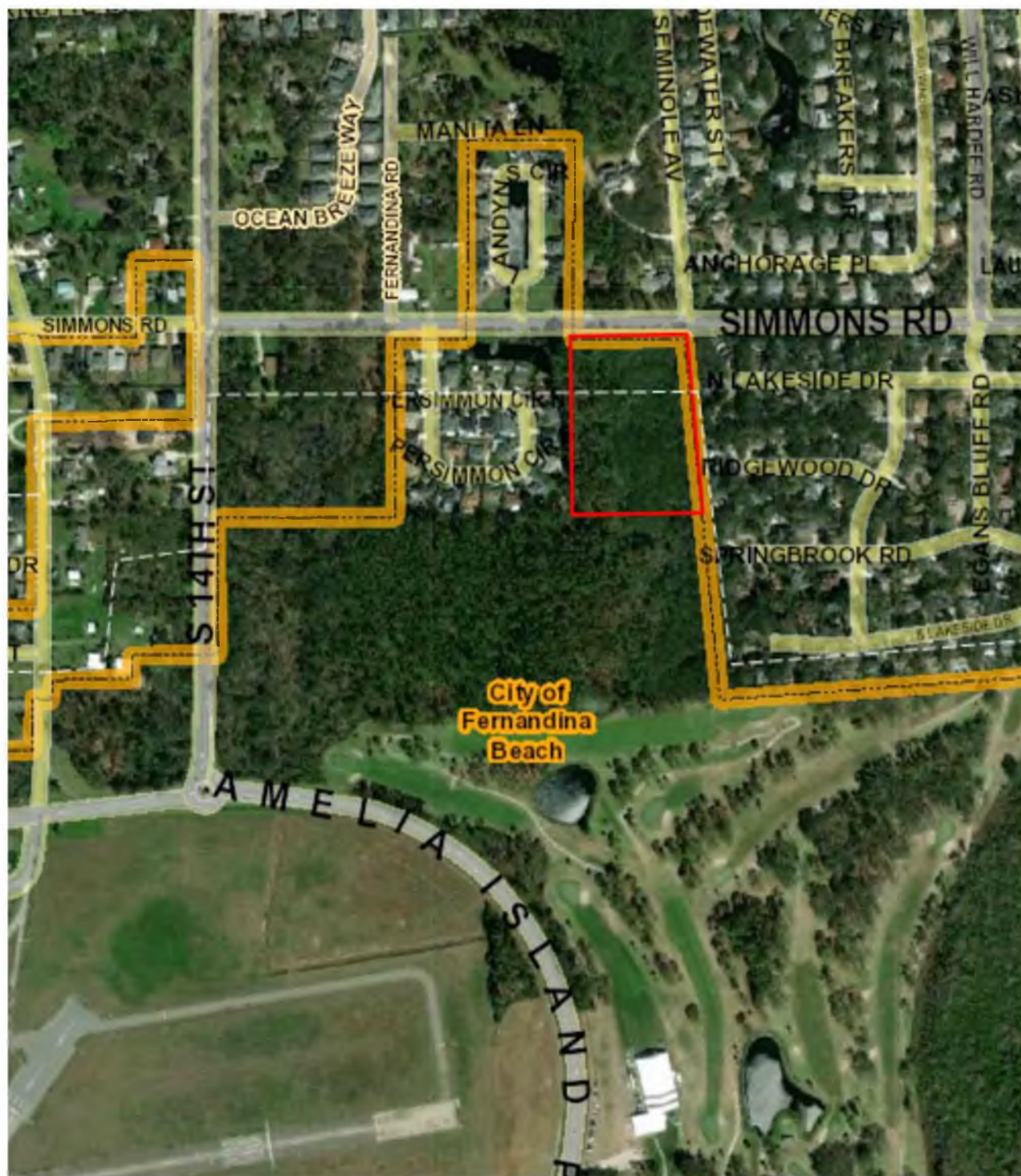

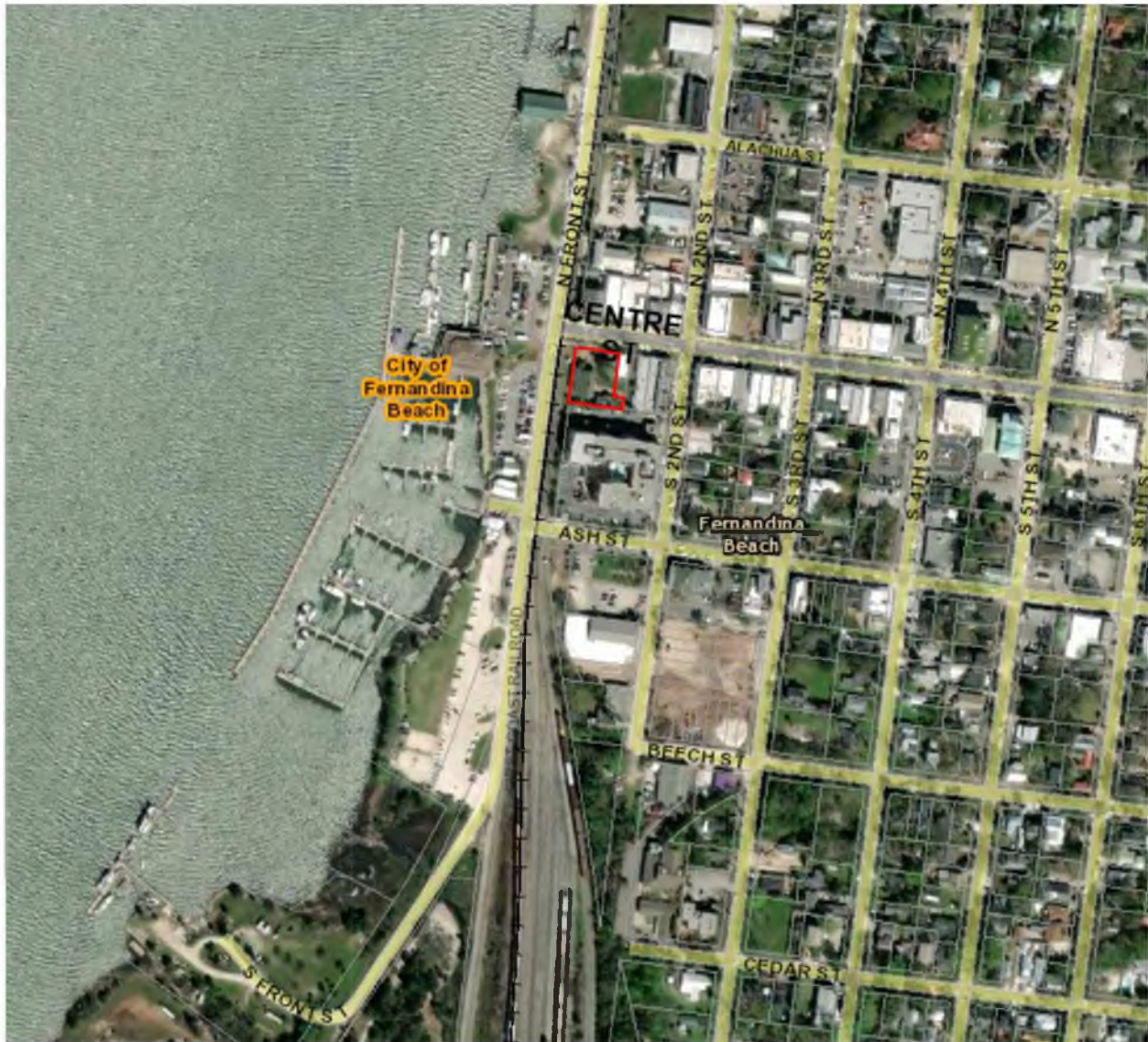
